

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,  
3 CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE  
4 MASTER PARKING SCHEDULE RESOLUTION TO ESTABLISH A TIMED  
NO PARKING ZONE ON FAIR ISLE DRIVE.

5 WHEREAS, the Public Works Department received a request from residents attending a  
6 March 16, 2015 neighborhood meeting on Paisley Court to allow on-street parking within the  
7 existing striped bike lane on the westerly side of Fair Isle Drive from Lockerton Lane to  
8 Abernathy Drive adjacent to Sycamore Highlands Park during park hours; and

9 WHEREAS, the residents indicated that the current no parking restriction adjacent to the  
10 park was limiting parking options for park patrons and resulting in overflow parking onto nearby  
11 residential streets, thereby reducing available on-street parking opportunities for residents and  
12 their guests; and

13 WHEREAS, the Public Works Department reviewed the request and concluded allowing  
14 cyclists and parked vehicles to share this segment of existing bike lane would enable removal of  
15 the no parking restriction during park hours, thereby encouraging park use and providing  
16 convenient parking for patrons while limiting the impacts of overflow parking on nearby  
17 residential streets; and

18 WHEREAS, due to a current street rehabilitation project happening in the immediate  
19 area, No Parking signs within the street segment were removed and Timed No Parking signs were  
20 installed in conjunction with the project.

21 WHEREAS, on May 6, 2015, the Transportation Board approved staff's recommendation  
22 on the establishment of the "No Parking between the Hours of 9:00 p.m. to 6:00 a.m. Daily" Zone  
23 on the westerly side of Fair Isle Drive from Lockerton Lane to Abernathy Drive.

24 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,  
25 California, as follows:

26 Section 1: The recitals set forth above are incorporated herein by reference.

Section 2: That the Master Parking Schedule is hereby amended by establishing a “No Parking between the Hours of 9:00 p.m. to 6:00 a.m. Daily” Zone on the westerly side of Fair Isle Drive from Lockerton Lane to Abernathy Drive.

Section 3: That the provisions of this resolution shall be operative only when signs are erected on that portion of the street set forth in Section 2 above, giving notice of the parking limitations or prohibitions herein established.

Section 4: The provisions of this amendment shall be operative as of the date of adoption of this resolution.
