**PROPOSAL:** Consider an appeal of the Planning Commission's approval of the following entitlements: (1) Minor Conditional Use Permit to permit the establishment of an outdoor storage yard for the storage of Recreational Vehicles and convert an existing 1,351 square foot residence into an office; and (2) Design Review of project plans.


