14. Director's Update regarding the main museum renovation, historic houses, collections, exhibitions and programs, staffing, advisory teams, volunteer and support opportunities, marketing, and communications.

In addition to the report Director Peterson reported that Museum staff are working on Harada outreach kits for elementary, to be rolled out to Harada Elementary School (formerly Highland Elementary School). The Museum hosted Doors Open with the exterior gates open for 150 attendees to learn more about the Harada House and family. The Museum participated in the Constitution Day event at the Riverside County Courthouse, with special guest appearances by Naomi Harada and House on Lemon Street author Mark Rawitsch. Students in attendance were able to have their complimentary book copy signed by Mr. Rawitsch during a lunch preceding the courthouse event. The last Open Lobby event will be hosted during Arts Walk on Thursday November 9th at the main museum, construction fencing will be erected in 2024. The Museum will be celebrating their 99th Anniversary with cupcakes at the main museum on December 12th from 4-6pm. The Museum welcomed new hires for the positions of Associate Educator, Exhibits Designer, Curator of History and Curator of Natural History. The Museum has extended an offer for the Coordinator of Institutional Advancement position. The Museum is updating a small exhibition space within the Arlington Library. The Museum's Nights with the Museum lecture series on the 1st Friday may have feature a different topic speaker as originally promoted due to scheduling changes.
