SUBJECT: EMERGENCY EXPENDITURES AND AIRPORT FACILITY MAINTENANCE

NEEDS IN THE AMOUNT OF \$160,000 - SUPPLEMENTAL APPROPRIATION

ISSUES:

Approve a supplemental appropriation from the Riverside Municipal Airport (Airport) Enterprise Fund to meet emergency expenditures and Airport facility maintenance needs in the amount of \$160,000.

RECOMMENDATION:

That the City Council, with at least five affirmative votes, approve a supplemental appropriation in the amount of \$160,000 from the Airport Fund's fund balance to the Airport Professional Services account.

BACKGROUND:

On June 16, 2020, the City Council approved and adopted the City's Fiscal Year (FY) 2020/21 Riverside Municipal Airport Budget. The Riverside Municipal Airport FY 2020/21 budget includes \$132,190 for professional services.

DISCUSSION:

The Riverside Municipal Airport (Airport) expended \$20,000 between July 2020 and February 2021 on emergency plumbing, door and window repairs; \$40,000 on emergency HVAC system replacement/repair; and, \$100,000 in storm roof damages for a total of \$160,000 in unanticipated expenditures.

The requested supplemental appropriation of \$160,000 will allow sufficient funding for the Airport to meet unanticipated facility maintenance and repairs outside of approved Capital Improvement Projects.

Maintenance and repairs associated with the appropriation include:

\$ 8,000	Terminal Door/Window Repairs
\$ 8,000	Plumbing Repairs
\$ 40,000	HVAC System Replacement/Repair
\$100,000	Roof Repairs

\$160,000 TOTAL EXPENDITURES

FISCAL IMPACT:

The cost of this action is \$160,000. City Charter Article XI Section 1103 requires that affirmative vote of at least five members of the City Council to authorize a supplemental appropriation. Upon City Council approval, funds would be appropriated from the Airport Fund fund balance, currently valued at approximately \$833,000. On March 23, 2021, a separate request for a supplemental appropriation from Airport fund balance will be submitted to Council to appropriate up to \$14,830 from Airport fund balance; if approved, available fund balance at the time of Council's consideration of this report will be valued at approximately \$818,000.
