BACKGROUND

- What is RIPA?
 - Enacted in 2015 under AB 953 to address racial and identity profiling in law enforcement.
 - Mandates data collection on law enforcement stops to improve transparency, accountability, and public trust.
 - Focus on preventing bias-based policing and creating equitable public safety practices



BACKGROUND

- Who does it apply to?
 - All law enforcement agencies in California
 - Agencies with 1,000+ officers began reporting in 2018, with all agencies phased in by 2023
 - The City of Riverside was part of Wave 3

 - January 1, 2021 – December 31, 2021
 - 19,267 Stops made
 - 157 Stops made outside of city limits
 - 19,110 Stops analyzed
 - 2024 RIPA Report
 - January 1, 2022 – December 31, 2022
 - 16,609 Stops made
 - 144 Stops made outside of city limits
 - 16,465 Stops analyzed
