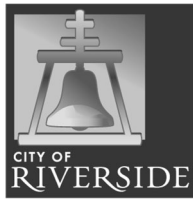

LEGAL BUDGET INCREASE - CITY ATTORNEY LEGAL FEES - SUPPLEMENTAL APPROPRIATION

The City Council (1) approved an increase to the legal budget for the law firm of Colantuono, Highsmith & Whatley in an amount not-to-exceed \$24,000 for a revised total budget of \$416,400; and (2) authorized the Chief Financial Officer, or designee, to record a supplemental appropriation in the amount of \$24,000 in the General Fund, City Attorney Legal Fees account.

FISCAL YEAR 2025-26 CITY SPONSORSHIP PROGRAM

The City Council approved the Economic Development Committee recommendation to (1) receive and order filed the City Sponsorship Program Report for the six-month period of July 1 to December 31, 2025; (2) approve City Sponsorship support, pending final budget approval for Fiscal Year 2025-26, in the form of monetary funding and/or in-kind contributions of \$140,537 for charitable and community events, which are produced by local non-profit organizations; and (3) authorize the City Manager, or designee, to make non substantive changes to the recommendations.

REJECT BID - VEHICLE REPLACEMENT ACCOUNT - FORD F350 XLT SUPER DUTY CREW CABS

The City Council (1) rejected the bid of Winner Chevrolet as non-responsive and awarded Bid 8171 to Diversified Leasing, Alhambra, for the purchase of three 2025 Ford F350 XLT Super Duty Crew Cabs for the City of Riverside Fire Department in the amount of \$253,434.18; and (2) authorized the City Manager or designee to execute any purchase orders, agreements, and other documents, including making any minor and non-substantive changes.

RATIFY PURCHASE ORDER 233777 - ARCHITECTURAL DESIGN SERVICES - PERMANENT SUPPORTIVE HOUSING PROGRAM

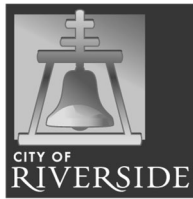
