Item 7 Library 101 Department Overview

Library Director Erin Christmas presented a "Library 101" overview, detailing the department's mission to serve as a community hub for lifelong learning and discovery. Supported by a staff of 74.50 FTEs, the library manages a diverse collection of print and digital resources for over 254,000 cardholders. Annual data highlighted the system's significant reach, including 1.6 million visits and nearly 2,500 community programs. Funded primarily through the General Fund and Measure Z, the presentation underscored the library's commitment to providing high-quality, inclusive municipal services to the City of Riverside. There was no action taken.

Item 8 Annual Designation of Nominating Committee
