BACKGROUND

- The City maintains street trees within the public right-of-way and parks to enhance the quality of life for all residents
- Riverside's urban forest includes approximately 35,000 park trees and 150,000 street trees
- Street trees are primarily located within parkways and along the front or side of homes and businesses
- The City's street trees have an estimated value of over \$449 million



MEASURE Z INVESTMENT TO REDUCE TRIM CYCLE

- 2017 \$1 million in annual Measure I funding was allocated to Urban Forestry to improve the 11-year tree trimming frequency cycle.
- A long grid cycle results in
 - increased service requests
 - more emergency calls
 - more claims
- Increased tree trimming funding allows Public Works to
 - Be more proactive
 - Identify diseased or dying trees before they become a problem

MEASURE Z INVESTMENT TO REDUCE TRIM CYCLE

- June 2022 the City Council approved an additional \$2,250,000 in Measure Z funding for trimming of City-owned palm trees, and planting of additional trees throughout the city
- Funding enables palm tree trimming every 2 years and helps retain a shorter trim cycle for other City-maintained trees
- Proper long-term care is essential to maintaining the health of the City's urban forest

AGREEMENT WITH WEST COAST ARBORIST

- June 12, 2018 following a competitive RFP process, City Council awarded an agreement in the amount of \$6,679,536 with an initial two-year term through June 30, 2021 and with three optional one-year extensions
- July 6, 2021 First Amendment executed to increase compensation by \$1,995,748 and extend the term by one year to June 30, 2022
- May 4, 2022 Second Amendment executed to increase compensation by \$2,154,345 and extend the term by one year to June 30, 2023
- December 21, 2022 Third Amendment executed to increase compensation by \$2,250,000
- June 30, 2023 Fourth Amendment executed to increase compensation by \$4,306,389 and extend the term by one year to June 30, 2024

FIFTH AMENDMENT TO AGREEMENT

- Finance Department considers contract extensions if vendor agrees to maintain current pricing at the level of services through the extended term
- 5th Amendment increases compensation in the amount of \$4,306,389 and extends term one year to June 30, 2025
 - Extension enables Public Works to provide the same level of service to the community for another year

Original term	\$6,679,536
First Amendment	1,995,748
Second Amendment	2,154,345
Third Amendment	2,250,000
Fourth Amendment	4,306,389
Fifth Amendment	4,306,389
Total	\$21,692,407

- Fifth Amendment to extend for one year will be the final extension.
- ➤ Public Works will prepare an RFP for tree maintenance services beyond June 30, 2025

- 2. Authorize the City Manager, or designee, to execute the Fifth Amendment, including making minor and non-substantive changes.
