A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 21052 AND THE MASTER FRINGE BENEFITS AND SALARY **CREATION PLAN** TO APPROVE THE OF THE CLASSIFICATION AND SALARY RANGE FOR THE URBAN FORESTRY AND LANDSCAPE SUPERVISOR; DELETION OF UTILITIES FISCAL MANAGER. PROGRAM COORDINATOR, AND HUMAN RESOURCES ADMINISTRATIVE TECHNICIAN CLASSIFICATIONS; AND APPROVE THE MISCELLANEOUS LANGUAGE CLEAN-UP MODIFICATIONS TO THE FRINGE BENEFITS AND SALARY PLAN.

WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the creation of the new classification and salary range for the Urban Forestry and Landscape Supervisor; and

WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the deletion of the Utilities Fiscal Manager, Annexation Program Coordinator, and Human Resources Administrative Technician classifications; and

WHEREAS, the FBSP needs to be revised to reflect miscellaneous language clean up modifications.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, as follows:

Section 1: Resolution No. 21052 and the Master Fringe Benefits and Salary Plan are hereby amended to 1) approve the creation of the new classification and salary range for the Urban Forestry and Landscape Supervisor; 2) approve the deletion of the Utilities Fiscal Manager, Annexation Program Coordinator, and Human Resources Administrative Technician classifications, all as set forth in Exhibit "A" attached hereto and incorporated herein by

1	reference; and 3) approve the miscellaneous language clean up modifications as set forth in
2	Exhibit "B" attached hereto and incorporated herein by reference.
3	Section 2: Authorize the City Manager, or designee, to ma.ke minor, non-substantive
