SECOND AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT - WATER COST OF SERVICE ANALYSIS AND RATE DESIGN

The Board of Public Utilities recommended that the City Council approve a Second Amendment to the Professional Consultant Services Agreement for Water Cost of Service Analysis and Rate Design with Carollo Engineers, Inc., Riverside, increasing the contract amount by \$40,000 for a total revised contract amount of \$214,832.
