



**CASE P14-0341 - REZONING - 10995 INDIANA - ORDINANCE ADOPTED**  
The City Council adopted an ordinance amending the Zoning Map of the City of Riverside pursuant to Chapter 19.090 of the Riverside Municipal Code rezoning 1.2 acres of vacant land at 10995 Indiana Avenue from Zone R-1-7000-SP to Zone CG-SP; whereupon, the title having been read and further reading waived, Ordinance No. 7346 of the City of Riverside, California, Amending the Zoning Map of the City of Riverside Pursuant to Chapter 19.090 of the Riverside Municipal Code by Rezoning Land from Zone R-1-7000-SP to Zone CG-SP, was presented and adopted.

**RIVERSIDE MUNICIPAL CODE UPDATE - CHAPTER 16 BUILDING AND CONSTRUCTION - ELECTRIC VEHICLE CHARGING STATIONS - ORDINANCE INTRODUCED**

### PROMISSORY NOTE AND DEED OF TRUST - CASA BLANCA HOME OF NEIGHBORLY SERVICE - 7680 CASA BLANCA

The City Council approved a 30-year Promissory Note and Deed of Trust between the Casa Blanca Home of Neighborly Service and the City of Riverside in the amount of \$525,000 from 2007 Casa Blanca Redevelopment Taxable Bond proceeds to finance the Casa Blanca Home of Neighborly Service's purchase of property at 7680 Casa Blanca Street and vacant land identified as Assessor Parcel Number 230-244-005, to continue operation of the community center for seniors and children.

### AGREEMENT - PURCHASE OF TAX-DEFAULTED PROPERTY - 5975 RUTLAND

The City Council (1) attested the Agreement between the County of Riverside and Alvord Unified School District for \$78,106.33 to Purchase Tax-Defaulted Property bearing Assessor Parcel Number 151-090-002 located at 5975 Rutland Avenue; and (2) authorized the City Manager, or his designee, to execute the Agreement including making minor and non-substantive changes.

### AGREEMENT - CONVEYANCE OF EASEMENT - RIVERSIDE TRANSMISSION RELIABILITY PROJECT - 3475 AND 3535 TYLER

The City Council (1) approved an Agreement for Conveyance of Easements with the property owner, Macy's West Stores, Inc., for the purchase price of \$103,100 from Public Utilities Electrical Capital Account for the Riverside Transmission Reliability Project for acquisition of three easements on a portion of 3475 and 3535 Tyler Streets, bearing Assessor Parcel Numbers 234-020-010, -045 and -046; and (2) authorized the City Manager, or his designee, to execute the Agreement, including making minor, non-substantive changes, and to sign all documents and instruments necessary to complete the transaction and to expend up to \$3,000 for title and escrow fees, and related miscellaneous closing costs, for a total project cost not-to-exceed \$106,100.



### MEMORANDUM OF UNDERSTANDING - RIVERSIDE UNIFIED SCHOOL DISTRICT - SCHOOL RESOURCE OFFICER PROGRAM

The City Council (1) approved the Memorandum of Understanding (MOU) with the Riverside Unified School District (RUSD) for the School Resource Officer program outlining terms, obligations and conditions in the amount of \$435,578 annually from the Police Department Budget through June 30, 2018; and (2) authorized the City Manager, or his designee, to execute the necessary contract documents.

### AGREEMENT AND ELECTRIC SERVICE CONTRACT FOR 30 MW OF HYDROELECTRIC POWER - BOULDER CANYON PROJECT


The City Council (1) approved the Electric Service Contract between the United State Department of Energy Western Area Power Administration and the City to continue electric service from the Boulder Canyon Project (Hoover Dam) through September 30, 2067; (2) approved the Implementation Agreement amongst the United States Department of Energy Western Area Power Administration, Bureau of Reclamation, and the City; (3) authorized the City Manager, or his designee, to execute any documents necessary to administer the Electric Service Contract and the Implementation Agreement; and (4) authorized the City Manager, or his designee, to terminate the Electric Service Contract for circumstances provided in the Agreement.

### REGENTS OF THE UNIVERSITY OF CALIFORNIA - WATER INNOVATIONS GRANT AGREEMENT

The City Council approved the University of California, Riverside request for a Water Innovations Grant in the amount of \$50,000, to be paid in three installments funded in Fiscal Year 2016-17, to research Electro-Oxidative Route towards Nitrate Removal from Drinking Water Resources using Activated Carbon as Electroactive Substrate.

### SPEED LIMIT ZONE - CENTRAL/DEWEY/FAIRVIEW/HAWARDEN/MISSION INN - ORDINANCE ADOPTED


The City Council adopted an ordinance to (1) establish a 35 MPH speed limit zone on Hawarden Drive from Arlington Avenue to Piedmont Drive South; (2) reduce the established speed limit on Fairview Avenue from Bronson Way to Alessandro Boulevard from 35 MPH to 30 MPH; (3) make the following changes on designated segments of Dewey Avenue: (a) revise the boundaries of the speed limit zone on Dewey Avenue from "Brockton Avenue to Streeter Avenue" to "Brockton Avenue to Juanro Way"; and (b) reduce the established speed limit on Dewey Avenue from Brockton Avenue to Juanro Way from 45 MPH to 40 MPH; (4) revise the boundaries of the 50 MPH speed limit zone on Central Avenue from "Canyon Bluff to the easterly City limits" to "Canyon Creek Drive to the easterly City limits"; and (5) revise the boundaries of the 35 MPH speed limit zone on Mission Inn Avenue from "Kansas Avenue to Lime Street" to "Lime Street to Eucalyptus Avenue"; whereupon, the title having been read and further reading waived, Ordinance No. 7347 of the City of Riverside, California Amending Section 10.76.010 of the Riverside Municipal Code Designating the Prima Facie Speed Limits for Streets and Portions Thereof in Accordance with the Provisions of Sections 10.20.020 and 10.20.030, was presented and adopted.

On August 23, 2016, the City Council unanimously approved retention of Think Legal360 in the matter of Bobby Harris, III v. City of Riverside, et al., RIC 1610330. City Attorney Geuss also reported that on August 23, 2016, pursuant to Government Code Section §54956.9(d)(2), the City Council unanimously approved in closed session settlement of a grievance filed by SEIU regarding the interpretation of certain language in the current Memorandum of Understanding (MOU) for this bargaining unit. Specifically, under the current MOU the City and SEIU agreed to transfer 2 percent of the employer paid member contribution to CalPERS for 3 years until a total of 6 percent of the EPMC was transferred to the employee. filed by SEIU on behalf of its members regarding the way in which the City was calculating the EPMC. SEIU maintains that the EPMC should be calculated based on the employee's taxable compensation. The City had been calculating the EPMC transfer based on the employee's pensionable compensation. In resolution of this grievance, the City Council voted in closed session to settle this grievance with SEIU. The City has agreed that as of July 1, 2016, all future calculations of the EPMC transfer will be calculated based off of the employees' taxable compensation. The City Council voted to ratify the City Manager's signing of a settlement agreement with SEIU on this issue.
