



MEASURE Z - BID 7823 - CANYON CREST DRIVE BUS STOP AND MAINTENANCE IMPROVEMENTS - REIMBURSEMENT AGREEMENT - UNIVERSITY/BLAINE - SUPPLEMENTAL APPROPRIATION

Following discussion, it was moved by Councilmember Melendrez and seconded by Councilmember Edwards (1) to award a construction contract for Bid 7823 for the Canyon Crest Drive Bus Stop and Maintenance Improvements from University Avenue to Blaine Street to Hillcrest Contracting, Inc., Corona, in the amount of \$1,552,898.35; (2) to authorize the City Manager, or his designee, to execute the construction contract with Hillcrest Contracting, Inc., including making minor and non-substantive changes; (3) to approve a reimbursement agreement with Riverside Transit Agency in the amount of \$1,150,000 to construct street and bus stop improvements associated with their facilities; (4) to authorize the City Manager, or his designee, to execute the reimbursement agreement with Riverside Transit Agency, including making minor and non-substantive changes; and (5) with at least five affirmative votes, authorize a supplemental appropriation in the amount of \$1,150,000 in the Capital Outlay Grants Fund for Riverside Transit Agency funds to the Canyon Crest Drive project account and increase the estimated revenue by the same amount. 
The City Council (1) approved the renewal of services provided through forty-two existing annual software and hardware maintenance and support or subscription agreements for Fiscal Year 2021/22 as listed in the staff report, where each agreement has aggregate expenditures over \$50,000 over the life of the agreement, or will be surpassing \$50,000, for an estimated total amount of \$2,709,672; (2) authorized a 15 percent change order authority for each annual renewal listed in Attachment 1 for Fiscal Year 2021/22, to be used in the event the estimated annual costs are higher than anticipated; and (3) authorized the City Manager, or designee, to execute all necessary documents for items listed in the staff report for Fiscal Year 2021/22, including, but not limited to, renewals, purchase orders, change orders, agreements, amendments, and other minor non-substantive changes.

MEASURE Z - BID 7842 - CHANGE ORDER AUTHORITY - DRIVEWAY AND PARKING LOT REPLACEMENT - MUSEUM OF RIVERSIDE HERITAGE HOUSE





Following discussion, it was moved by Councilmember Edwards and seconded by Councilwoman Plascencia (1) to award a Construction Agreement for Bid 7841 for the conversion of an existing industrial building for bridge housing to R. Dependable Construction, Inc., San Bernardino, in the amount of \$1,160,900 plus a 20 percent contingency for a total amount of \$1,393,080; (2) to approve a Second Amendment and Restated Subrecipient Agreement for the 2018 Homeless Emergency Aid Program (HEAP) Capital Improvement Projects with the County of Riverside for an additional allocation of HEAP funding in the amount of \$254,500; (3) with at least five affirmative votes, authorize increase in revenue and appropriated expenditures in an equal amount of \$254,500 in the Development Grants Fund HEAP Homeless Emergency Aide Account; (4) to authorize the City Manager, or his designee, to execute the Construction Agreement with R.
