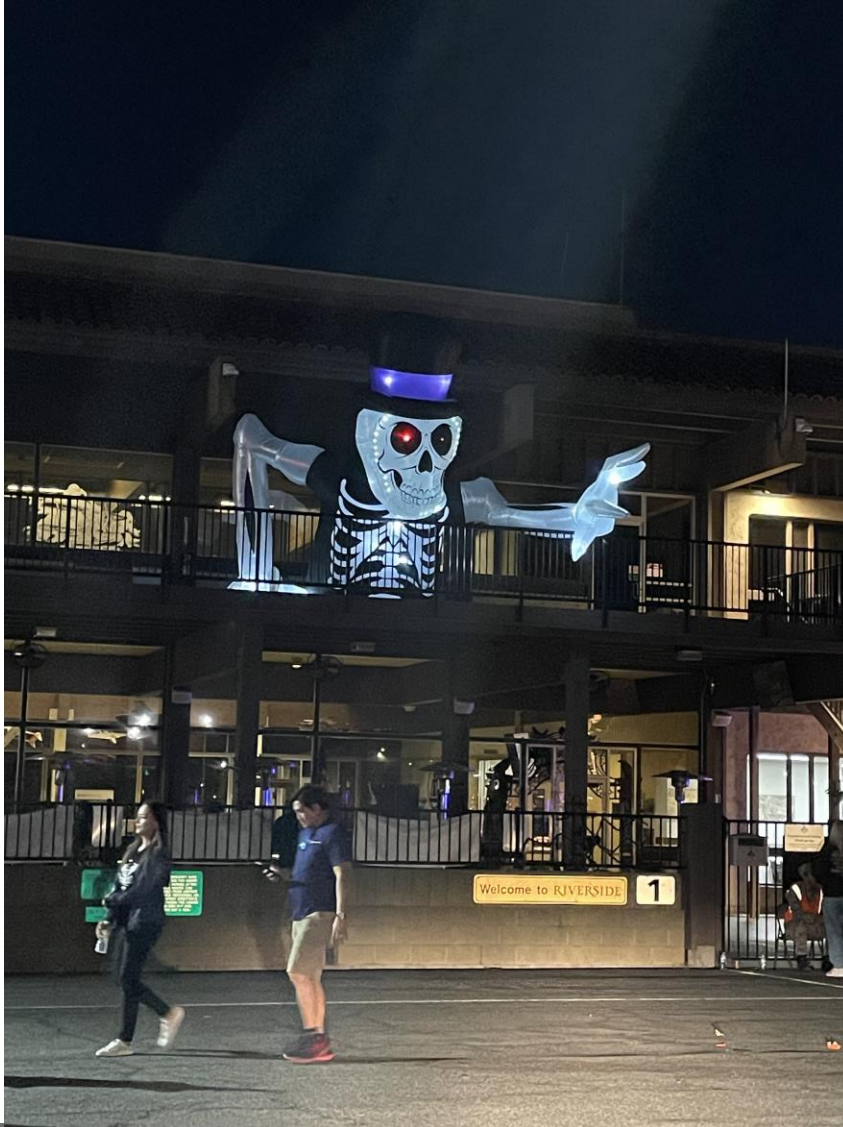

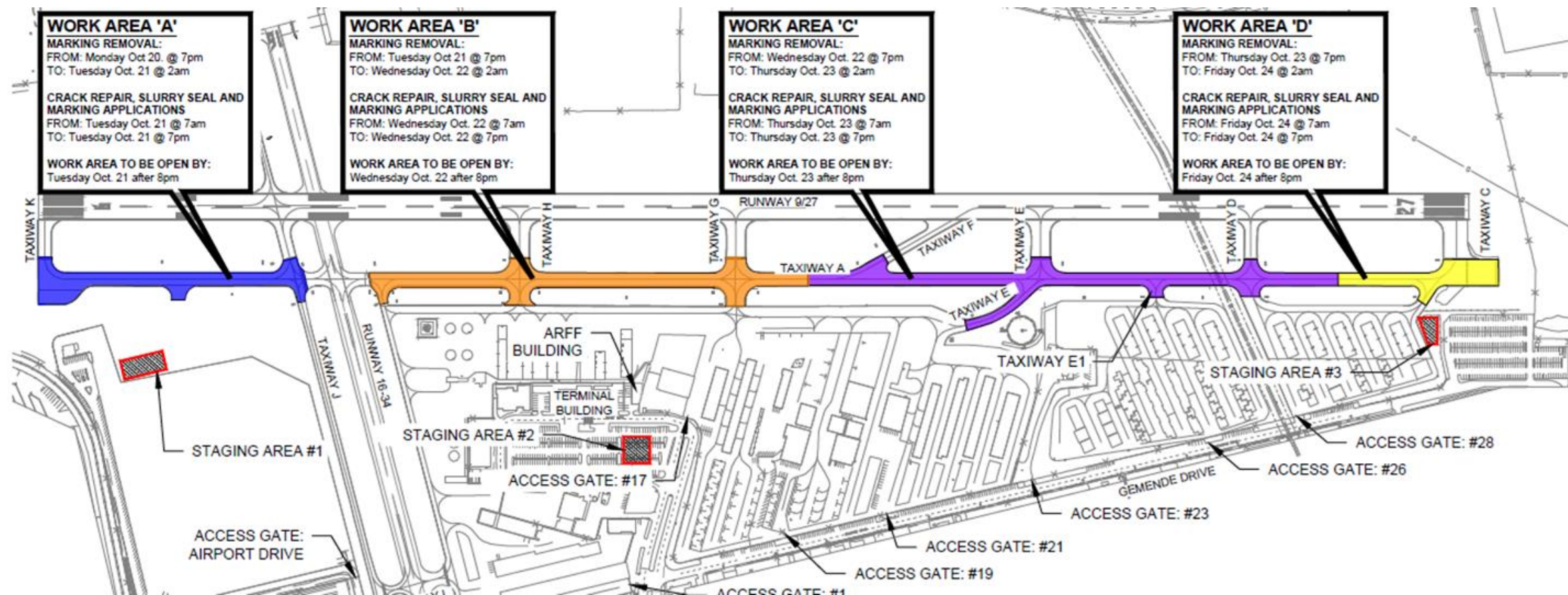
# TAXIWAY A REHAB

1. 1900L, October 20 until 2000L October 21: Taxiway A CLOSED West of Runway 16/34. Taxiway J CLOSED south of Runway 16/34 and north of Taxiway L. Runway 16/34 will remain open. Runway 9 intersection departures from runway 16/34 with 4,300 ft remaining.
2. 1900L, October 21 until 2000L October 22: Taxiway A CLOSED between 16/34 and Taxiway F. Taxiway B, between Runway 9/27 and the ramp CLOSED. Taxiway H CLOSED. Taxiway G CLOSED. Taxiway F will remain Open.
3. 1900L October 22 until 2000L October 23: Taxiway A CLOSED between Taxiway G and Taxiway C. Taxiway F CLOSED. Taxiway E CLOSED. Taxiway D CLOSED. Taxiway C will remain open. Taxiway G will remain open.
4. 1900L October 23 until 2000L October 24: Taxiway A CLOSED east of Taxiway D. Taxiway C CLOSED. Runway 27 intersection departures from Taxiway D with 4,500 ft remaining.

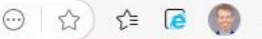

- A Resolution of the City Council of the City of Riverside, California, Authorizing the Application and Acceptance of Grant Funds of \$283,366 from the Federal Aviation Administration for the Design Phase of Runway 9-27 Runway Safety Area Erosion Control Project at the Riverside Municipal Airport; and Authorizing the Execution of all Necessary Documents Related to Such Grant
- A Resolution of the City Council of the City of Riverside, California, Authorizing the Application and Acceptance of Grant Funds of \$104,500 from the Federal Aviation Administration for the Development of an Airport Pavement Management System (APMS) at the Riverside Municipal Airport; and Authorizing the Execution of all Necessary Documents Related to such Grant
