SUBJECT: AWARD BID NO. 8140 FOR NEW WROUGHT IRON FENCING AT HERITAGE HOUSE TO HARRIS STEEL FENCE COMPANY, INCORPORATED, OF LOS ANGELES, CALIFORNIA, IN THE AMOUNT OF \$120,429 WITH 15% CHANGE ORDER AUTHORITY FOR A TOTAL AMOUNT OF \$138,493

#### ISSUE:

Award Bid No. 8140 for new wrought iron fencing at Heritage House to Harris Steel Fence Company, Incorporated, of Los Angeles, California, in the amount of \$120,429 with 15% change order authority for a total amount of \$138,493.

### **RECOMMENDATIONS**:

That the City Council:

- 1. Award Bid No. 8140 for new wrought iron fencing at Heritage House to Harris Steel Fence Company, Incorporated of Los Angeles, California, for a construction contract in the amount of \$120,429;
- 2. Approve change order authority for Bid No. 8140 for new wrought iron fencing at Heritage House to Harris Steel Fence Company, Incorporated in the amount of \$18,064 (15% of the contract) for a total amount of \$138,493; and
- 3. Authorize the City Manager, or designee, to execute the construction contract with Harris Steel Fence Company, Incorporated, including making minor and non-substantive changes.

### BACKGROUND:

The Heritage House Victorian house museum has a few areas that are not served by adequate perimeter fencing, providing opportunity for unauthorized access to the Heritage House site. This has resulted in vandalism and garbage left on the site. This project will add fencing to areas that do not have sufficient perimeter fencing to prevent unauthorized access to the Heritage House site.

### **DISCUSSION**:

On November 22, 2024, Bid No. 8140 for new wrought iron fencing at Heritage House was posted on Planet Bids.

## Bid No. 8140 – Bidding Notification Summary Table

A mandatory Pre-Bid Meeting was held on December 10, 2025, with eight (8) vendors in attendance. RFB 8140 closed on January 7, 2025, with a total of three (3) bids received for new wrought iron fencing at Heritage House. The lowest responsive bid was from Harris Steel Fence Company, Incorporated in the amount of \$120,429, which was 4% less than the next lowest responsive bid.
