

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
RIVERSIDE, CALIFORNIA, ADOPTING A TITLE VI NON-
DISCRIMINATION POLICY IN ACCORDANCE WITH THE CIVIL
RIGHTS ACT OF 1964.

WHEREAS, the City of Riverside, as a local agency and recipient of Federal financial assistance is required to comply with various nondiscrimination laws and regulations including Title VI of the Civil Rights Act of 1964 and related statutes; and

WHEREAS, the City of Riverside is required to institute and maintain a Title VI Program in accordance with the Civil Rights Act of 1964 and related statutes as required by 23 CFR Part 200 and to adopt a policy for such program; and

WHEREAS, the policy shall include a statement that the City of Riverside, under Title VI of the Civil Rights Act of 1964 and related statutes, ensures that no person in the City of Riverside shall, on the ground of race, color, national origin, sex, disability, or age, be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity it administers.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

Section 1: The City of Riverside hereby adopts a Title VI Policy that shall read as follows:

“The City of Riverside, under Title VI of the Civil Rights Act of 1964 and related statutes, ensures that no person in the City of Riverside shall, on the ground of race, color, national origin, sex, disability, or age, be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity it administers.”
