**APPLICANT:** Jarod and Stephanie DeAnda


**LOCATION:** 5050 Myrtle Avenue, on the east side of Myrtle Avenue between Victoria Avenue and Ivy Street, in Ward 3.

**PROPOSAL:** The Cultural Heritage Board recommends that the City Council consider approval of a Historic Designation request for City Landmark designation of Woolley Residence.

**ENVIRONMENTAL DETERMINATION:** The Cultural Heritage Board recommends that the City Council determine that this proposal is exempt from the California Environmental Quality Act (CEQA), pursuant to Sections 15061(b)(3) (Common Sense Rule) and 15308 (Actions by Regulatory Agencies for Protection of the Environment), as this proposal will not have a significant effect on the environment, preserve the historic character of a cultural resource, and provide notice of the resource historic status.
