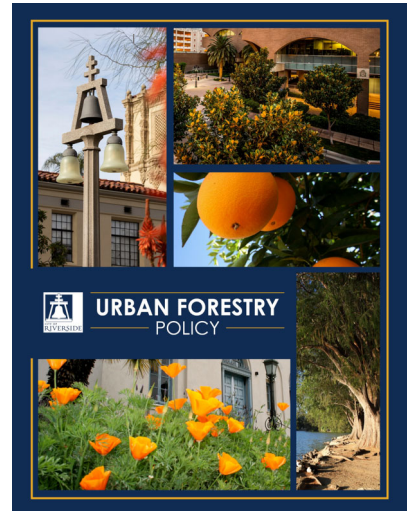

 - Requested modifications
 - Requested recommendations from Park and Recreation Commission Ad Hoc Committee

 - July 13, 2022: Meeting at Riverside-Corona Resource Conservation District



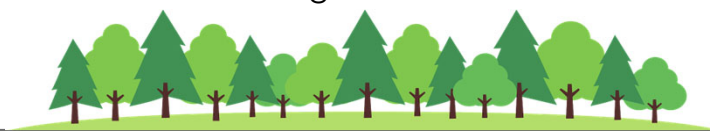

BACKGROUND

- January 9, 2023 - Progress Update
 - Committee feedback and additional work time
 - Update Manual branding
 - Community notification for tree removals
 - Perpetual Tree Care and Planting Fund options
 - Periodic updates to the Committee
- March 3, 2023 - Updated Manual Draft to reflect City branding
- March 13, 2023 - Tree Removal Standard Operating Procedure including notification methods for non-hazardous tree removals
- Perpetual Tree Care and Planting Fund

DISCUSSION

- May 8, 2023 – Staff presented final draft of Manual updates
 - Committee unanimously recommended City Council to approve Manual updates
- April 2023 - USDA-Forest Service released guidelines for multiyear, competitive grants for tree planting/related activities.
- September 2023 - Public Works notified of \$1 million grant award for comprehensive tree inventory and development of in-house database/inventory management system

NOTEWORTHY ENDEAVORS

1. Feeding America Partnership
 - Gleaning fruit from public ROW orange trees on Victoria Avenue
2. Complete Streets Ordinance
 - Expanding tree planting opportunities in public roadway projects
 - Requiring street trees in participating development projects
3. Measure Z Allocation: Palm Tree Trimming
 - Additional \$2M for trimming all City palms on a two-year cycle
4. Measure Z Allocation: Tree Planting
 - Additional \$250,000 to plant more trees
