

**THIRD AMENDMENT TO OFFICIAL POLICE TOW TRUCK SERVICE  
AGREEMENT**

**ANGELOS ENTERPRISES, INC. dba ANGELO'S TOWING**

This THIRD AMENDMENT to OFFICIAL POLICE TOW TRUCK SERVICE AGREEMENT ("Third Amendment") is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2020, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation ("City") and ANGELOS ENTERPRISES, INC., a California corporation doing business as ANGELO'S TOWING (hereinafter referred to as "Contractor"), with respect to the following facts:

**RECITALS**

WHEREAS, on December 12, 2016, City and Contractor entered into that certain Official Police Tow Truck Service Agreement for Contractor to perform vehicle towing and storage services for the City's Police Department pursuant to the terms and conditions stated therein ("Agreement"); and

WHEREAS, the initial term of the Agreement expired January 1, 2019, unless extended; and

WHEREAS, on December 5, 2018, City and Contractor entered into that certain First Amendment to the Agreement ("First Amendment") which extended the Agreement term for one additional year to expire December 31, 2019; and

WHEREAS, on December 12, 2019, City and Contractor entered into that certain Second Amendment to the Agreement ("Second Amendment") which extended the Agreement term for one additional year to expire December 31, 2020; and

WHEREAS, Riverside Municipal Code ("RMC") Section 5.15.080(B) authorizes official police tow service agreements to be extended three times, for up to one (1) additional year each; and

WHEREAS, RMC Chapter 5.15 – "Regulation of Riverside Police Official Police Tow Truck Service" has been amended since City and Contractor entered into the Agreement; and

WHEREAS, City and Contractor desire to amend the Agreement a third time and extend the Agreement term for an additional one (1) year period to expire December 31, 2021; and

WHEREAS, City and Contractor desire by this Third Amendment to acknowledge that RMC Chapter 5.15 has been amended since City and Contractor entered into the Agreement, and to agree to be subject to RMC Chapter 5.15 in its revised and current form.

NOW, THEREFORE, in consideration of the foregoing recitals, which are incorporated herein by this reference, City and Contractor agree as follows:

1. The Agreement Term shall be extended for one (1) additional year, with a new expiration date of December 31, 2021.
2. City and Contractor acknowledge that Riverside Municipal Code Chapter 5.15, "Regulation of Riverside Police Official Police Tow Truck Service" has been amended since City and Contractor entered into the Agreement, and City and Contractor agree to be subject to RMC Chapter 5.15 in its revised and current form.
3. All terms and conditions of the Agreement not inconsistent with the First Amendment, Second Amendment, and this Third Amendment shall remain in full force and effect and are incorporated herein by this reference as if set forth in full.
