WHEREAS, City and Contractor desire to increase compensation by an additional amount of Forty-Nine Thousand Dollars (\$49,000.00), for a revised total contract amount not to exceed Ninety-Eight Thousand Dollars (\$98,000.00).

NOW, THEREFORE, in consideration of the foregoing recitals, which are incorporated herein by this reference, City and Instructor mutually agree as follows:

- 1. Section 3, "Compensation", is hereby amended to increase compensation by an additional amount of Forty-Nine Thousand Dollars (\$49,000.00), for a revised total contract amount not to exceed Ninety-Eight Thousand Dollars (\$98,000.00).
- 2. All terms and conditions of the Agreement not inconsistent herewith shall remain in full force and effect and are hereby incorporated by reference into this First Amendment as though set forth in full herein.
