### **CALL TO ORDER**

The meeting was called to order at 3:02 p.m. by Board Chair Barnhart.

#### **2. Riverside Museum Associates (RMA) quarterly update**

RMA President Robin Whittington gave an update about the purpose of RMA and their financial stewardship funds held for the benefit of the Museum, including funds for exhibitions, education, Nature Lab, Harada House, Heritage House, and more. RMA volunteers are preparing to bring back docents, including new training and re-opening plans coordinated with staff.

#### **3. Harada House Foundation (HHF) quarterly update**

HHF President Sarah Mundy reported that new members have joined the HHF Board to expand outreach beyond Riverside and the Inland Empire. The account balance has hit the \$100,000 mark and continues to grow with donations. Another Harada webinar event discussing crimes against Asians will be hosted in June.

Museum Director Peterson reported that in addition to the report included in the Board packet, the Harada House Foundation and Museum of Riverside webinar is scheduled for June 10<sup>th</sup> from 6-7:30 p.m. with the goal of providing audience participants with practical tools to combat hate crimes. The Museum has applied for Community Benefit Funding through Congressman Takano's office for funding to complete equipping the Harada House Interpretive Center/Robinson House, including museum-appropriate HVAC systems. The City of Riverside has a new Strategic Plan as of fall 2020 and, at a future Board meeting, the Board will hear how the Museum is aligning its own Strategic Plan with the City's Strategic Plan.
