ORDINANCE NO.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING SECTIONS 19.250.020, 19.250.025, 19.410.030, 19.450.020, 19.580.060, 19.620.080, 19.690.050, 19.740.050, 19.780.060, 19.910.020, 19.910.060, 19.910.150, 19.910.170, AND 19.910.200 AND TABLES 19.100.070, 19.150.020A, 19.150.020B, 19.150.020C, AND 19.740.020 OF THE RIVERSIDE MUNICIPAL CODE.

The City Council of the City of Riverside does ordain as follows:

Section 1: Sections 19.250.020, 19.250.025, 19.410.030, 19.450.020, 19.580.060, 19.620.080, 19.740.050, 19.780.060, 19.910.020, 19.910.060, 19.910.150, and 19.910.170 and Tables 19.100.070, 19.150.020A, 19.150.020B, 19.150.020C, and 19.740.020 of the Riverside Municipal Code are revisions directly related to Entertainment Permits and hereby amended as set forth in Exhibit “A” attached hereto and incorporated herein by reference.

Section 2: Sections 19.690.050 and 19.910.200 of the Riverside Municipal Code are clean-up items not related to Entertainment Permits and are hereby amended as set forth in Exhibit “B” attached hereto and incorporated by reference.

Section 3: The City hereby finds that this ordinance is not subject to review under the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines sections 15060, subdivision (c)(2) (the activity will not result in a direct or reasonably foreseeable indirect physical change in the environment) and 15061, subdivision (b)(3) (there is no possibility the activity in question may have a significant effect on the environment).
