#### WORKSHOP

PROPOSED AMENDMENTS TO RIVERSIDE MUNICIPAL CODE CHAPTER 19.620 - SIGN ORDINANCE

Following discussion, it was moved by Chair Mill and seconded by Vice Chair Falcone to (1) forward the potential sign code amendments to include window sign standards, particularly vacant storefronts, standards for Blade signs and Electronic Message Center signs/digital displays, codification of certain Design Guidelines, Special tools for technical assistance like toolkits and handouts for Planning Commission consideration and recommendation; and (2) directed staff to return to Committee in February with a Sign Code Tool Kit Pricing update. The motion carried unanimously.

Riverside Municipal Code by adding Chapter 16.80 related to the Vehicle Miles Traveled (VMT) Impact Fee Mitigation Program; (3) adopt a Resolution modifying the existing California Environmental Quality Act (CEQA) VMT transportation Impact threshold to the current jurisdictional baseline VMT per capita for new residential projects and the current jurisdictional baseline VMT per employee for new office and industrial projects and revise the Traffic Impact Analysis (TIA) Guidelines; and (4) Direct staff to conduct a workshop to educate the development community in the application of the new vehicle miles traveled mitigation program including a training session on the TredLite software to address projects with transportation related VMT impacts. The motion carried unanimously.
