UPDATES ON CONFERENCES, SEMINARS AND REGIONAL MEETINGS ATTENDED BY COMMISSIONERS

Commissioner Mickelson shared that she had visited the Community Access Center located in Riverside to learn more about the RAMP Program, which provides free accessibility ramps to low-income individuals with disabilities who require a ramp to enter their home.

Commissioner Mickelson also shared her visit to the Office on Aging, located at Mission Grove and Central, where she encountered difficulty locating the office due to a lack of signage. Commissioner Mickelson plans to reach out to the Advisory Council on Aging to recommend improvements for improved navigation and public access.

Commissioner Tarmo shared that she visited Therapeutic Riding Therapy Services, a nonprofit organization that specializes in therapeutic riding for individuals with disabilities.

Commissioner Lee shared that he had attended an educational tour of the Police Station, hosted by Police Chief Gonzalez

Commissioner Lee also shared that he had attended a facility tour of the City's Homeless Access Center and learned about the services and resources that are available to homeless individuals.
