following services: Senior Grab and Go Meal Program, CARES Act Recreation Activity Teen Boxes; Riverside Green (Insect Explore, Let's Garden), Riverside Fit, JOY: Just older Youth. The boxes are available for tots, youth, teens, young adults and seniors and the Halloween Event "Chutes and Candy" as well as all the American Red Cross Blood Drives.

Discussion on Current COVID-19 stat

Director Cruz reported that the City of Riverside is not testing to the state average, 129 city staff had been tested on Thursday, October 15 and future dates at Dales Senior Center for city staff testing. Director Cruz described regressing to widespread stage, what that means and how often people should get tested, what needs to happen to move forward to the next level changes to occur; the time frame required; positivity rates; testing numbers and protocol if numbers change.
