

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 RIVERSIDE, CALIFORNIA, APPROVING THE APPLICATION
4 FOR LAND AND WATER CONSERVATION FUND FOR THE
5 CAMP EVANS AT FAIRMOUNT PARK EXPANSION
6 PROJECT.

7 WHEREAS, the Congress under Public Law 88-578 has authorized the establishment of
8 a federal Land and Water Conservation Fund Grant-In-Aid program, providing matching funds
9 to the State of California and its political subdivisions for acquiring lands and developing
10 facilities for public outdoor recreation purposes; and

11 WHEREAS, the California Department of Parks and Recreation is responsible for
12 administration of the program in the State, setting up necessary rules and procedures governing
13 applications by local agencies under the program; and

14 WHEREAS, the City of Riverside, as the applicant, certifies by resolution the approval of
15 the application and the availability of eligible matching funds prior to submission of the
16 application to the State

17 NOW THEREFORE, BE IT RESOLVED that the City Council of the City of Riverside,
18 hereby:

19 Section 1: Approves the filing of an application for Land and Water Conservation
20 Fund assistance for the proposed Camp Evans at Fairmount Park Expansion Project.

21 Section 2: Agrees to abide by Section 6(f)(3) of Public Law 88-578 which states “No
22 property acquired or developed with assistance under this section shall, without the approval of
23 the National Secretary of the Interior, be converted to other than public outdoor recreation uses.
24 The Secretary shall approve such conversion only if he finds it to be in accord with the then
25 existing comprehensive statewide outdoor recreation plan and only upon such conditions as he
26 deems necessary to assure the substitution of other recreation properties of at least equal fair
27 market value and of reasonably equivalent usefulness and location.”

28 Section 3: Certifies that said agency has matching funds from eligible source(s) and

1 can finance 100 percent of the Project, which up to half may be reimbursed.

2 Section 4: Delegates the authority to the City Manager or his designee as agent of the
3 applicant to conduct all negotiations and execute and submit all documents, including, but not
4 limited to, applications, contracts, amendments, payment requests, and compliance with all
5 applicable current state and federal laws which may be necessary for the completion of the
6 aforementioned project.
