Chair Armas called the meeting to order at 5:30 p.m.

### **APPROVAL OF MINUTES**

Motion was made by Member Soza and seconded by Member Moran approving the September 4, 2019, Transportation Board meeting minutes as presented.

Motion carried unanimously.

### **DISCUSSION CALENDAR**

#### **AMBER STREET – ESTABLISHMENT OF TIMED NO STOPPING ZONE**

Following discussion motion was made by Member Moran and seconded by Vice Chair Sheth recommending that the Transportation Board recommend that the City Council approve establishment of a “No Stopping Between the Hours of 6:00 p.m. and 6:00 a.m. Daily” zone on both sides of Amber Street from the southerly terminus south of Haskell Street to 40 feet northerly thereof.

Motion carried unanimously.

#### **MINNIER AVENUE – ESTABLISHMENT OF A TIMED NO STOPPING ZONE**

Following discussion motion was made by Member Soza and seconded by Member Brown recommending that the Transportation Board recommend that the City Council approve establishment of a timed No Stopping zone on the west side of Minnier Avenue from Whitford Avenue to 350 feet southerly thereof.

Motion carried unanimously.

## **PARK AVENUE – REMOVAL OF A SEGMENT OF TIMED 2-HOUR PARKING ZONE AND CORRECTION OF REMAINING NORTHERLY ZONE BOUNDARY**

Following discussion motion was made by Vice Chair Sheth and seconded by Member Brown recommending that the Transportation Board recommend that the City Council:

1. Removal of the segment of the existing “2-Hour Parking 9:00 a.m. to 6:00 p.m. except Sunday and holidays” zone on both sides of Park Avenue from Eleventh Street to Twelfth Street; and
2. Correction of the boundaries of the remaining northerly “2-Hour Parking 9:00 a.m. to 6:00 p.m. except Sunday and holidays” zone changing the northerly boundary from its former name of “Seventh Street” to the current street name of “Mission Inn Avenue”.

Motion carried unanimously.

## **SPEED LIMIT ZONE ESTABLISHMENT & REVISION – ALHAMBRA AVENUE AND BOX SPRINGS BOULEVARD**

Two emails were received in favor of the establishment of 25 MPH speed limit zone on Alhambra Avenue. Following discussion motion was made by Member Moran and seconded by Member Soza recommending that the Transportation Board recommend that the City Council adopt an ordinance to:

1. Establish a 25 MPH speed limit zone on Alhambra Avenue between La Sierra Avenue and Cypress Avenue; and
2. Revise the boundaries of the 40 MPH speed limit zone on Box Springs Boulevard from “Sycamore Canyon Boulevard to Fischer Road” to “Sycamore Canyon Boulevard to River Crest Drive”.

Motion carried unanimously.
