### ATTENDANCE

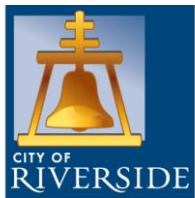
The Human Relations Commission excused the absence of Commissioner Goe from the meeting on July 25, 2024.

### FORMING HOUSING AD HOC

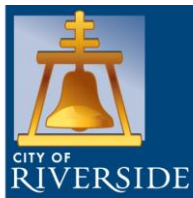
