HOUSING AUTHORITY'S PROJECTS UPDATE


Following discussion and without formal motion, the Committee received and ordered filed an update on the Housing Authority's projects.

The Committee received an update on (1) Senate Bill 634 – prohibit local jurisdictions from adopting a local ordinance that prohibits a person or organization from providing support services to a person who is homeless; (2) Senate Bill 346 – authorize local agencies to regulate short term rental and transient occupancy tax; (3) Senate Bill 79 – build more multi-family housing near rail stations and rapid bus lines; and (4) Senate Bill 27 - expansion of Care Court.

The Committee received an update on the Homeless Housing, Assistance and Prevention Program Round 6.
