BACKGROUND

- 1. JW North WTP began operation in Sept 2008.
- 2. Key water treatment facility to the City.
- 3. The 30-ton AC unit failed due to a damaged air handler and condenser.
- 4. Bid No. RPU-2352 was posted on the city's online bid system.
- 5. Bidding closed on March 5, 2024, with two responsive bidders.

DISCUSSION

- 1. In December 2024, Paradigm Mechanical Corp notified the City of additional electrical work needed.
- 2. The new total amount quoted was \$242,835.
- 3. City Purchasing staff confirmed with the second bidder, Pacific West Industrial Inc. that their original bid was still valid.

• After Considering the updated cost proposal by Paradigm Mechanical Corp, Purchasing staff has deemed Pacific West Industries Inc. as the best overall bidder.
