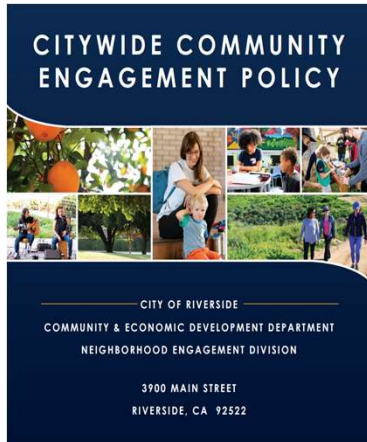

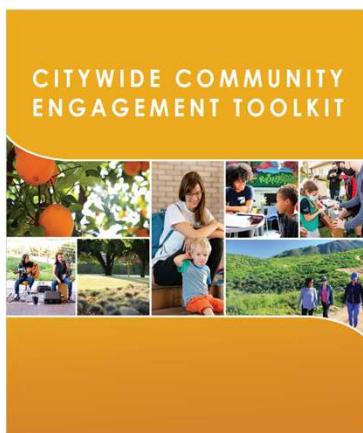

- ☒ Adopting Citywide Plans
- ☒ Adopting budgets
- ☒ Creating local laws
- ☒ Declaring special rates or charges
- ☒ Selling, exchanging, or leasing land
- ☒ Entering into regional agreements
- ☒ Deviating or discontinuing a road
- ☒ Making amendments to the General Plan

COMMUNITY ENGAGEMENT WILL BE LIMITED

- ☒ An immediate resolution is required
- ☒ Technical or other expertise is required
- ☒ An initiative involves confidential information
- ☒ There are clear and defined legislative responsibilities that require compliance
- ☒ Emergency response is necessary
- ☒ There is a risk to public safety
