MEMORANDUM OF UNDERSTANDING - COLLABORATIVE AFTERSCHOOL PROSOCIAL OPPORTUNITIES FOR DISADVANTAGED YOUTH

The City Council (1) approved a Memorandum of Understanding between Riverside Unified School District and the City of Riverside Afterschool Prosocial Collaborative; and (2) authorized the City Manager, or designee, to execute all necessary documents and approve future addendums to the Memorandum of Understanding.

AVIATION PROGRAM AGREEMENT AMENDMENT - SUPPLEMENTAL APPROPRIATION The City Council (1) approved the Fifth Amended Aviation Program Agreement between the City of Riverside and the City of Corona for a one-year term for the period of July 1, 2022 through June 30, 2023 for a total amount of \$120,000; (2) with at least five

affirmative votes, authorized an increase in revenues in the General Fund, Aviation Miscellaneous Revenue account in the amount of \$120,000 and appropriated expenditures in the amount of \$70,000 and \$50,000 to the General Fund, Aviation Unit – Non-Stock Inventory and Motor Fuels & Lubricants expenditure accounts, respectively; and (3) authorized the City Manager, or designee, to execute the necessary contract documents with the City of Corona including making minor and non-substantive changes.

REQUEST FOR PROPOSAL 1890 - AGREEMENT AMENDMENTS - ENERGY DELIVERY CONSULTANT SERVICES FOR VARIOUS CAPITAL IMPROVEMENT PROJECTS

The City Council (1) approved thirteen amendments to the Master Professional Consultant Services Agreement Extensions for the Energy Delivery Consultant Panel in response to Request for Proposal 1890 for Energy Delivery Consultant Services for various Public Utilities Capital projects with a not-to-exceed total compensation limit of \$2,000,000 per consultant for a one-year term, with option to extend for one additional one-year term; and (2) authorized the City Manager, or designee, to execute the thirteen amendments to Master Professional Consultant Services Agreement for the Energy Delivery Consultant Panel with each of the consultant firms listed in the staff report, including one additional one-year term agreement extensions, making minor non-substantive changes, and supplemental agreements, upon Board of Public Utilities work order approval, and terminate, upon mutual consent, any Master Agreement.

PROHIBIT AND ENFORCE WATER THEFT AND UNAUTHORIZED WATER USE - ORDINANCE INTRODUCED

The City Council introduced an Ordinance adding Chapter 14.23 to the Riverside Municipal Code to prohibit and enforce water theft and unauthorized water use; whereupon, an ordinance entitled, "An Ordinance of the City of Riverside, California, Adopting Chapter 14.23 of the Riverside Municipal Code to Prohibit and Enforce Water Theft and Unauthorized Water Use, was presented and introduced.

EMERGENCY PURCHASE ORDER - TEMPORARY BELT PRESS RENTAL AND DEWATERING SERVICES

The City Council (1) approved an Emergency Purchase Order for the Temporary Press Rental and Dewatering Services, an urgent necessity to protect the public health, welfare, safety, and property in accordance with the Purchasing Resolution No. 23812 Section 301(c), with SYNAGRO-WWT, INC. Baltimore, Maryland, in the amount of \$311,320;
