A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 21052 AND THE MASTER FRINGE BENEFITS AND SALARY TO APPROVE THE CREATION CLASSIFICATIONS SALARY RANGES **FOR** COMMUNICATIONS DIRECTOR MARKETING AND DEPUTY MARKETING AND COMMUNICATION DIRECTOR CLASSIFICATIONS; AND SALARY ADJUSTMENTS TO THE EXISTING LIBRARY DIRECTOR CLASSIFICATION.

WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the salary adjustment for the existing Library Director.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, as follows:

Section 1: Resolution No. 21052 and the Master Fringe Benefits and Salary Plan are hereby amended to (i) approve the creation of the new classification and salary range for the Marketing and Communications Director and Deputy Marketing and Communications Director; and (ii) approve the salary adjustment for the existing Library Director, all as set forth in Exhibit "A" and Exhibit "B" attached hereto and incorporated herein by reference.

<u>Section 2</u>: Authorize the City Manager, or designee, to make minor, non-substantive changes to the Master Fringe Benefits and Salary Plan and any related policies, procedures or documents necessary to implement these provisions.
