The motion carried with Councilmembers Edwards, Cervantes, Conder, Perry, and Hemenway voting aye and Councilmember Fierro and Councilwoman Plascencia absent.

Following further discussion, it was moved by Councilmember Cervantes and seconded by Councilmember Hemenway to refer the addition of seven 0.5 part-time equivalent Council Assistants to the proposed amended budget for the General Fund with a fiscal impact of \$272,272 and related adjustments to the cost allocation plan to the next budget cycle with deeper analysis of staffing. The motion failed for lack of four affirmative votes with Councilmembers Edwards, Cervantes, and Hemenway voting aye, Councilmembers Conder and Perry voting no, and Councilmember Fierro and Councilwoman Plascencia absent.
