### **9. Harada House Foundation (HHF) – quarterly update**

Natalie Komuro gave an update on behalf of Sarah Mundy. Three new Board members have joined the HHF Board. The HHF Board is excited to contribute to the Museum and provide funding for the Harada documentary, and HHF is proud of their collaborating partnership with the Civil Rights Institute of Inland Southern California for their project *Building Our Region's Korean Communities* exhibition opening July 24<sup>th</sup>.

### **10. Riverside Museum Associates (RMA) – quarterly update**

Chuck Wilson gave the quarterly update and distributed printed copies of the RMA annual report for 2024/25. The report (also available on the RMA website) reflects the implementation of the recently updated RMA Strategic Plan. Features include an updated financial report layout, increased communication to the public, digital newsletter, and fundraising events. A Sip & Paint event was recently held and well attended. The RMA Multicultural Committee (MCC) continues to spread awareness and education through our local schools with outreach and participation in events such as Juneteenth. New Museum of Riverside Board member Mary Carter volunteered to assist with a future RMA Sip & Paint event.

### **11. Director's Update regarding the main museum renovation, historic houses, collections, exhibitions and programs, budget, staffing, advisory teams, volunteer and support opportunities, and marketing and communications.**

In addition to the submitted written report, Director Peterson reported that the construction fencing at the main museum is up, including the pedestrian access tunnel on Orange Street. The general contractor is waiting for the submittal from the historic preservation subcontractor (Spectra), which will guide the demolition process.

Three interviews will be held next week for the Archivist position. A planning committee has been created for the main museum grand opening; one Museum Board member will be requested to serve on the committee for this multi-day event. The Harada architect and engineering team were on site to discuss the house lifting process. On July 28. Board Member Rodriguez will tour the Museum's collections storage sites; up to three additional Board members may attend the tour as well.

Board members Rodriguez and Cardullo attended the City's Arts & Culture luncheon. Board member Barnhart complimented Museum staff on the Groundbreaking Ceremony for the main museum.
