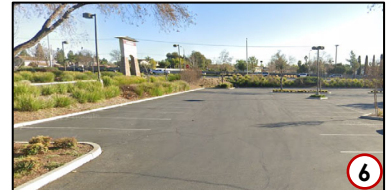

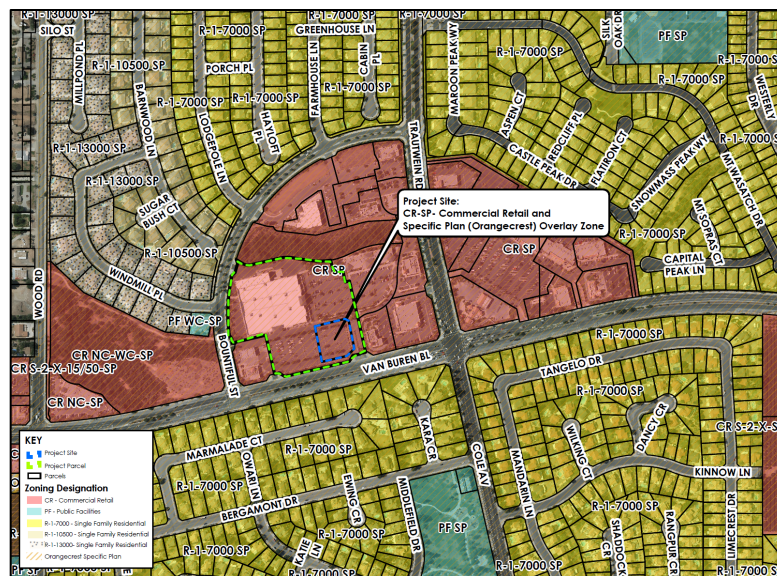

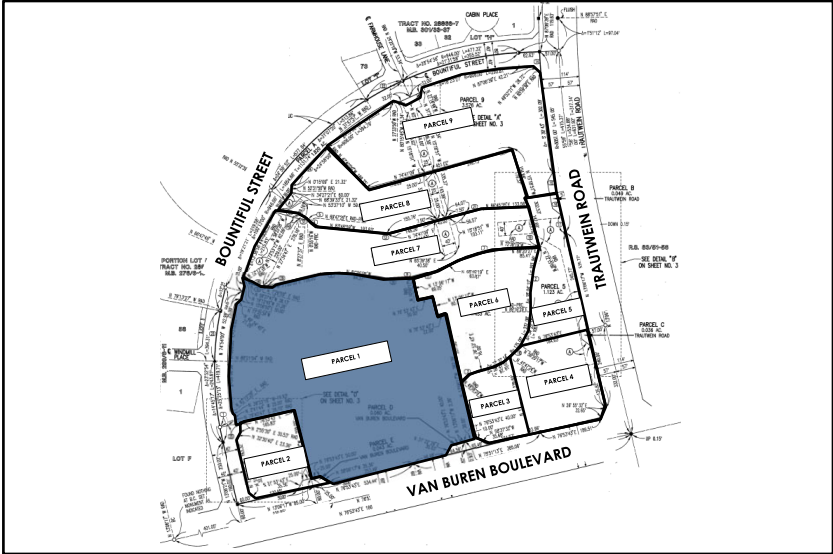
SPECIFIC PLAN AND ZONING MAP

MODIFICATION OF CONDITION - PM-30369



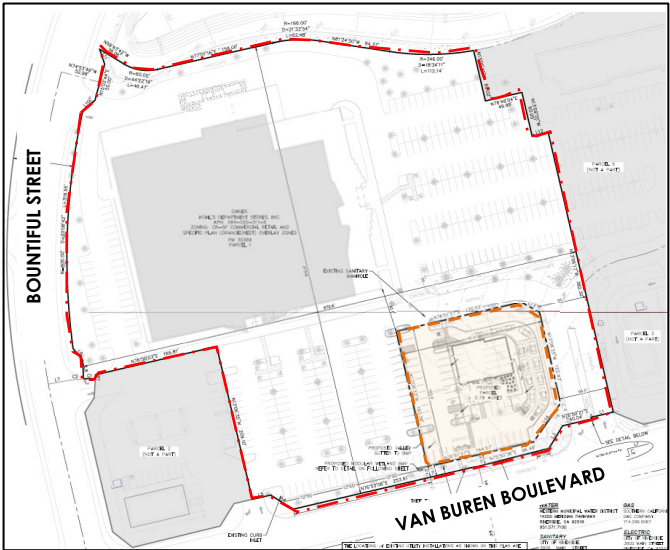

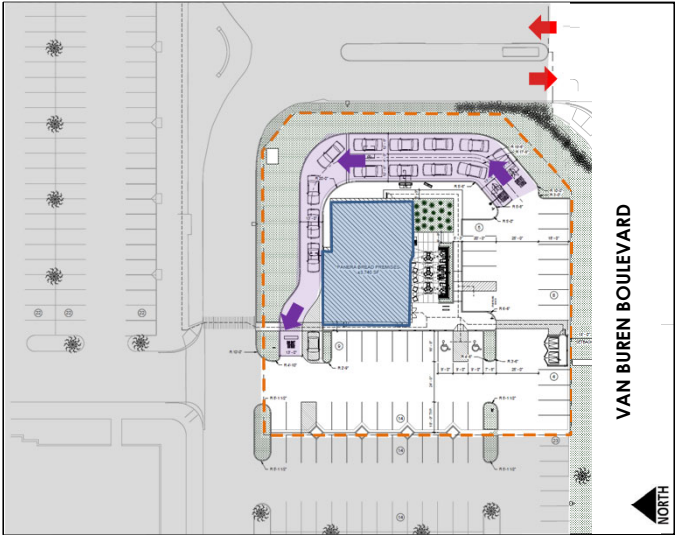

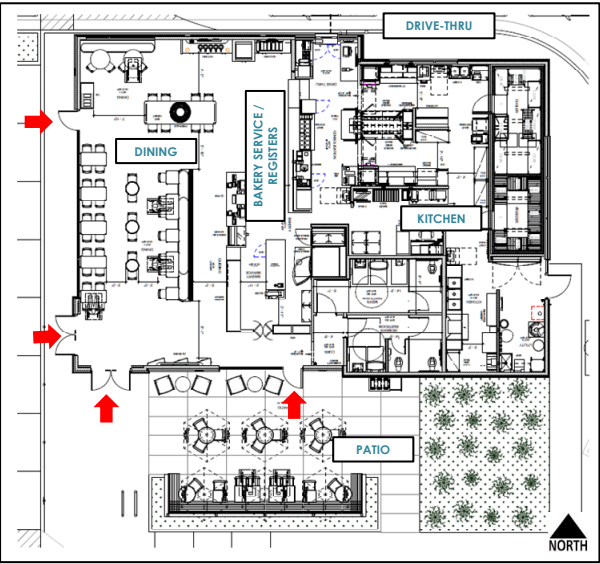

FLOOR PLAN

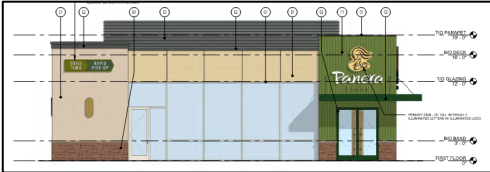

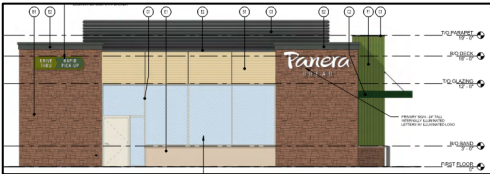

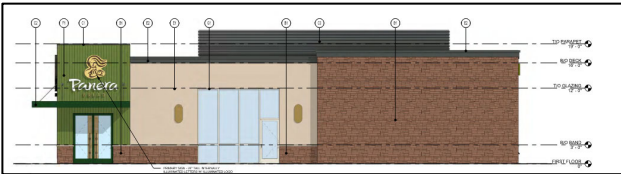
WEST ELEVATION

If the motion passes:

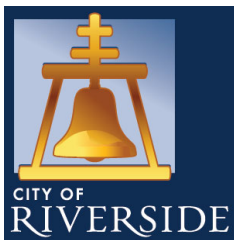

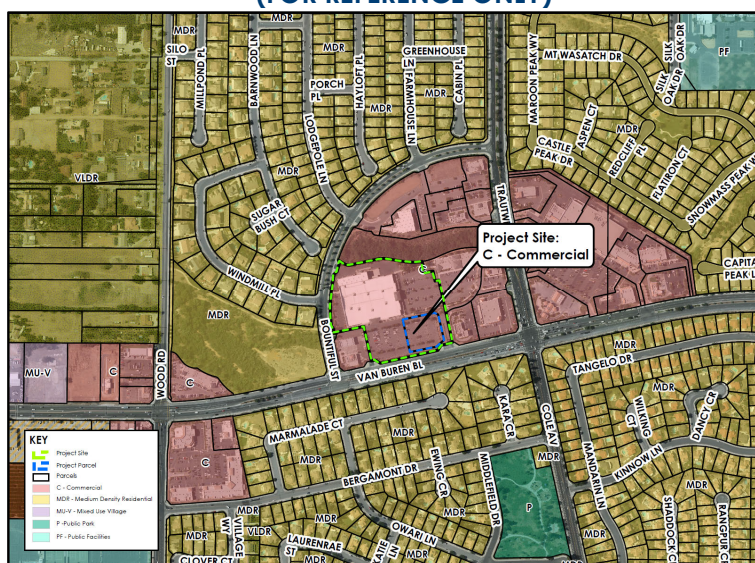
