

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,  
3 CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE  
4 MASTER PARKING SCHEDULE RESOLUTION TO REMOVE A SEGMENT  
OF 2-HOUR PARKING ZONE ON MAIN STREET.

5 WHEREAS, on March 4, 2015, the Transportation Board ("Board") reviewed a request  
6 supported by a petition from 83% of the businesses located on the westerly side of Main Street  
7 from SR-60 to Poplar Street for removal of the 2-Hour Parking Zone within that street segment to  
8 provide needed long-term parking; and

9 WHEREAS, the Board voted unanimously to deny the initial request for removal of the  
10 2-Hour Parking Zone and asked that the Public Works Department return to the Board with an  
11 alternate recommendation at the next scheduled Board meeting; and

12 WHEREAS, the Public Works Department recommended removing the 2-Hour Parking  
13 Zone only within the portion north of 2605/2609 Main Street and the 2-Hour Parking Zone would  
14 remain in effect from the northerly property line at 2605/2609 Main Street southerly to Poplar  
15 Street; and

16 WHEREAS, the new proposal would provide both short-term and long-term parking  
17 opportunities with the entire street segment to better serve the needs of all businesses in the  
18 immediate area and would also update the Master Parking Schedule to accurately reflect the prior  
19 removal of the 2-Hour Parking Zone on Main Street from SR-60 to south of Spruce Street; and

20 WHEREAS, on May 6, 2015, the Transportation Board approved staff's recommendation  
21 to remove the segment of "2-Hour Parking between the Hours of 9:00 a.m. to 6:00 p.m. of Any  
22 Day except Sunday and Holidays" Zone on the westerly side of Main Street from SR-60 to 310  
23 feet northerly of Poplar Street.

24 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,  
25 California, as follows:

26 Section 1: The recitals set forth above are incorporated herein by reference.

27 Section 2: That the Master Parking Schedule is hereby amended by removing the segment  
28 of "2-Hour Parking between the Hours of 9:00 a.m. to 6:00 p.m. of Any Day except Sunday and

1 Holidays” Zone on the westerly side of Main Street from SR-60 to 310 feet northerly of Poplar  
2 Street.

3 Section 3: That the provisions of this resolution shall be operative only when signs are  
4 erected on that portion of the street set forth in Section 2 above, giving notice of the parking  
5 limitations or prohibitions herein established.

6 Section 4: The provisions of this amendment shall be operative as of the date of adoption  
7 of this resolution.
