The minutes of the meeting of April 25, 2024, were approved as presented.

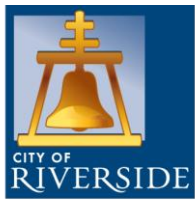
ATTENDANCE

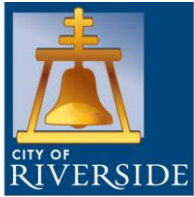
