BACKGROUND

1. Utility line clearance includes tree trimming and vegetation management services and is a vital function of RPU to maintain safe clearance between electric lines and trees
2. Safety and reliability of service demand vegetation management in accordance with California Public Utilities Commission's General Order 95 Rule 35
3. RPU trims approximately 25,000 trees per year to keep safe clearances and reduce threats of service interruptions and wildfires

Line clearance work requires use of certified tree trimmers and certified arborists as per the ANSI Tree Pruning Standards, Industry leading practices, and the City's Urban Forestry Policy

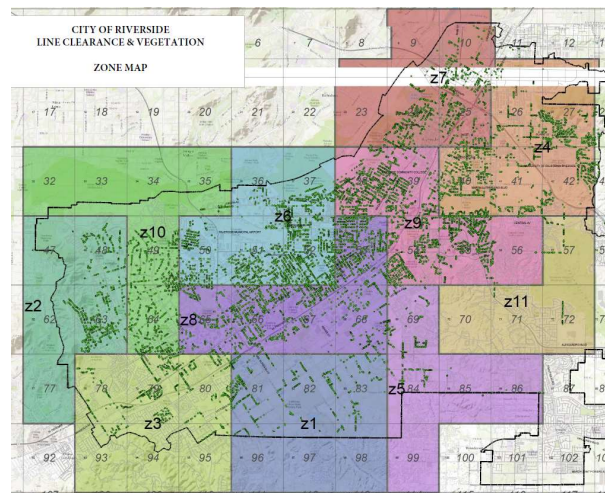

4. 91 miles of transmission lines

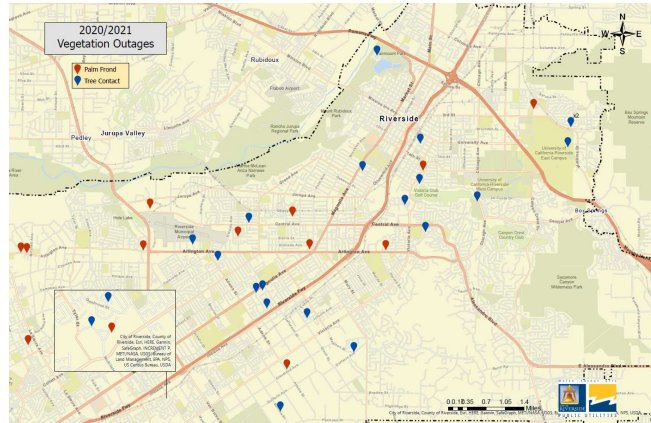

1. Bid No. RPU-7922 was posted on PlanetBids on July 11, 2022, and closed July 27, 2022
2. Five bids were received
3. Staff evaluated the bids and deemed West Coast Arborist, Inc., of Grand Terrace, California the lowest responsive and responsible bidder

RECOMMENDATIONS

That the Board of Public Utilities:

1. Award Bid. No. RPU-7922 for the Utility Line Clearance, and Vegetation Management Service to West Coast Arborists, Inc., of Grand Terrace, California, for a five-year term ending October 31, 2027, in the amount of \$20,000,000, with two optional one-year extensions;
2. Approve change order authority of 10%, in the amount of \$2,000,000; and
3. Authorize the City Manager, or designee, to execute the agreement and optional contract extensions, including making minor and non-substantive changes in alignment with all purchasing policies.
