

1 RESOLUTION NO. 23385

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, AUTHORIZING THE CITY MANAGER TO EXECUTE ON
4 BEHALF OF THE CITY OF RIVERSIDE ALL NECESSARY
5 APPLICATIONS, CONTRACTS, PAYMENT REQUESTS, AGREEMENTS
6 AND AMENDMENTS IN THE PROCESS OF APPLYING FOR AND
7 SECURING FUNDS UNDER THE CALIFORNIA DEPARTMENT OF
8 RESOURCES RECYCLING AND RECOVERY (CALRECYCLE) FISCAL
9 YEAR 2018/19 BEVERAGE CONTAINER RECYCLING CITY/COUNTY
10 PAYMENT PROGRAM.

11 WHEREAS, pursuant to Public Resources Code section 40000 et seq., the Department of
12 Resource Recycling and Recovery (CalRecycle), is to administer various Grant Programs (“grants”)
13 in furtherance of the State of California’s (“State”) efforts to reduce, recycle and reuse solid waste
14 generated in the State thereby preserving landfill capacity and protecting public health and safety
15 and the environment; and

16 WHEREAS, in furtherance of this authority, CalRecycle is required to establish procedures
17 governing the application, awarding and management of the grants; and

18 WHEREAS, CalRecycle’s Beverage Container Recycling City/County Payment Program
19 application procedures require an applicant’s governing body to declare by resolution certain
20 authorizations related to the administration of CalRecycle grants; and

21 WHEREAS, the City of Riverside (“City”) desires to establish a Beverage Container
22 Recycling City/County Payment Program in accordance with CalRecycle’s Program and also desires
23 to extend the City Manager’s authority to include the authority to apply for and secure the available
24 funds on behalf of the City available under CalRecycle’s Beverage Container Recycling City/County
25 Payment Program, and carryout all other purposes in the application process administered by
26 CalRecycle, and such authority shall be valid from the date of adoption of this Resolution up to and
27 including June 30, 2023.

28 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
California, as follows:

Section 1: The City Council of the City of Riverside does hereby authorize application to
CalRecycle for a Beverage Container Recycling City/County Payment Program.
