BACKGROUND

- Residents have been complaining about the noise coming from the Downtown area and unpermitted house parties.
 - Bars and nightclubs within the Downtown area have seen growth in popularity, and the noise generated as increased over time.
 - Corresponds with increased calls for service and violent activity.

BACKGROUND

- RPD has also seen an increase in unpermitted house parties ("flyer parties").
 - Promoters will advertise a party on social media 24 to 48 hours prior to the event, typically held at a vacant house or building.
 - These parties will have a DJ, fully functional bar, and charge admission.
 - Unlicensed security.
 - · Often armed.
 - Increase in litter, drug activity, noise complaints, vehicle/pedestrian traffic, violent altercations between homeowners and party goers.

EXAMPLES

- The Downtown Experiment
 - Wednesday 11/27/24 RPD observed the bar full of customers after 10 p.m.
 - Noise and music projected outdoors through outdoor speakers and the business not keeping doors closed.
 - Sunday 10/27/24 RPD responded to PC664/187 inside the bar.
- July 28, 2024 Flyer Party Shooting
 - RPD responded to another PC664/187 inside a "flyer party" which occurred between two groups of individuals.
 - RPD Robbery/Homicide and Gang units are investigating.
 - Left at least one partygoer in the hospital with serious injuries.

SIMILAR ORDINANCES IN OTHER JURISDICTIONS

- Municipalities that have Adopted "Plainly Audible" or "Reasonable Person" Standards in Ordinances:
 - City of Corona (CMC 9.24.010)
 - County of Riverside (RCO 9.52.060(C))
 - City of Fontana (FMC 18-63(b))
 - County of San Bernardino (SBCO 24.0705, 24.0706)
- Each Ordinance Addresses:
 - Licensing requirements for special events;
 - Noise or sound that is "plainly audible" from a given distance; and
 - Includes a reasonable person standard.

RIVERSIDE MUNICIPAL CODE

- Section 7.35.010 General Noise Regulations
 - Subds. A and B currently restricts "any noise disturbance".
 - Subd. C's plainly audible standard only includes transmission of sound through walls of adjoining units within a building.
- Section 7.10.125 "Noise Disturbance" Defined
 - "Noise disturbance" means any sound which, as judged by a City police officer or code enforcement officer, annoys or disturbs a reasonable person of normal sensitivities or exceeds a standard set forth in this title.
 - Does not include "plainly audible."
 - Reasonable person standard should be included in 7.35.010 or cross-referenced within that section, along with the other factors.
- Existing law accounts for variances and permitted activities
 - Chapter 7.40 includes a permitting process for variances.
 - Chapter 19.250 addresses entertainment permits.

RIVERSIDE MUNICIPAL CODE

Section 7.35.010 – Fines and Penalties

- Currently limits administrative fines for a violation of this chapter to the \$100, \$200, \$500 amounts in Section 1.17.230.
 - These fine limits were originally set by state statute in 1983.
- This amendment would increase the fine amounts to \$500 upon a first violation, \$750 upon a second violation, and \$1000 upon a third or subsequent violation.
 - Would now account for over 40 years of inflation and rapid population growth in the downtown area.

RECOMMENDATIONS

That the City Council:

- 1. Receive the following report and presentation proposing amendments to Riverside Municipal Code sections 7.15.010 and 7.35.010;
- 2. Amend Municipal Code Section 7.15.010 to increase the fine amounts for violations of the noise ordinance;
- 3. Amend Municipal Code section 7.35.010 to cross-reference and include the reasonable person standard listed in section 7.10.125;
- 4. Amend Municipal Code section 7.35.010 to add Subdivision D, which includes a plainly audible standard of 25 feet.
