Mayor Lock Dawson called the meeting to order at 3:00 p.m.

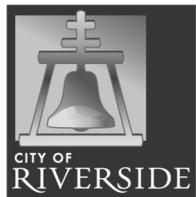
Councilmember Cervantes entered the meeting at 3:10 p.m.

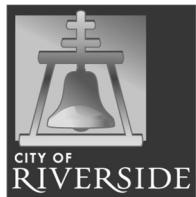

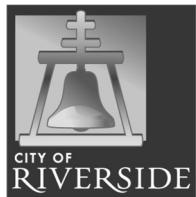

#### MEMORANDUM OF UNDERSTANDING - LEARNING INSTITUTE FOR FLIGHT TECHNOLOGY (LIFT)

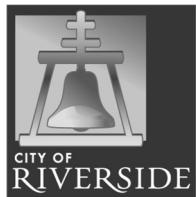

The City Council directed staff to cancel the regularly scheduled meeting on Tuesday, June 2, 2026, due to the General Municipal Election occurring on the same date.

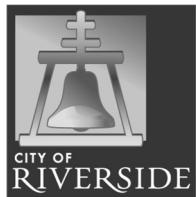
#### AMENDMENT AGREEMENT - CONSULTING AND ADMINISTRATIVE SERVICES - 6951 FLIGHT

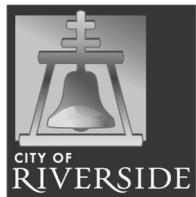
#### CASE PC-2025-01067 (VC-S) - SUMMARY STREET/ALLEY VACATION - WHITTIER PLACE - RESOLUTION

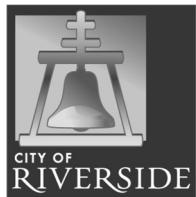
#### EMERGENCY ROOF REPLACEMENT - 2801-2880 HULEN PLACE - RESOLUTION


#### PURCHASE OF HYPERCONVERGED INFRASTRUCTURE (HCI) SOLUTIONS

#### AMENDMENT AGREEMENT - SCOPE OF WORK - RIVERSIDE CONNECT

The City Council (1) approved increasing to the (SHARE) deposit/urgent notice assistance from \$150 to \$250, effective from the end of the State of California's COVID-19 Emergency on February 28, 2023; and (2) approved continuing the (SHARE) monthly assistance increases in alignment with planned water and electric rate increases through 2028.



#### SPEED HUMPS - FIRST/MAIN/MULBERRY

The City Council approved the proposed speed humps on First Street between Mulberry Street and Main Street in support of the Transportation Board's recommendations.

#### GRANT APPLICATION - UNITED STATES DEPARTMENT OF TRANSPORTATION COMMERCE - PUBLIC WORKS AND ECONOMIC ADJUSTMENT ASSISTANCE GRANT PROGRAM - HIGH-SPEED TRAFFIC SIGNAL COMMUNICATIONS INTELLIGENT INFRASTRUCTURE SYSTEM - UNIVERSITY/CENTRAL AVENUES

The City Council authorize the Public Works Department to submit a funding application for the Public Works and Economic Adjustment Assistance Grant Program offered by the United States Department of Transportation Commerce in an amount up to \$1,500,000 for the Innovation Corridor Transportation Connectivity Project that will install high-speed traffic signal communications intelligent infrastructure systems along the University Avenue and Central Avenue corridors which represent a critical investment in economic development, and establishes the baseline for future advancements in transportation technology.

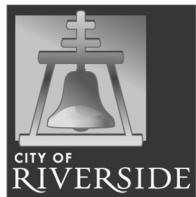

#### IMPLEMENTATION OF TEMPORARY TWELVE-MONTH TRAFFIC CIRCULATION PILOT PROJECT - MADISON/ EMERALD - MADISON/FREDA - CONTINUED


Following discussion, it was moved by Councilmember Mill and seconded by Councilmember Conder to continue the temporary twelve-month traffic circulation pilot project to prohibit through and left-turn movements at the eastbound and westbound approaches at the intersections of Madison Street and Emerald Street and Madison Street and Freda Avenue to address community concerns to a future City Council meeting date for further consideration. No one spoke on the matter. The motion carried unanimously.

#### PUBLIC HEARING

#### CASE PR-2023-001523 - ZONING CODE TEXT AMENDMENTS - TITLE 19 - ORDINANCE INTRODUCED

Public Hearing was called to consider amendments to numerous sections of Title 19 of the Riverside Municipal Code regarding Zoning including but not limited to Articles V Base Zones and Related Use and Development Provisions, VII Specific Land Use Provisions, and X Definitions related to City's industrial development standards. Eight people spoke on the matter. The public hearing was officially closed.

Following discussion, it was moved by Councilmember Cervantes and seconded by Councilmember Falcone to (1) determine that Planning Case PR-2023-001523 Zoning Text Amendment is exempt from further California Environmental Quality Review pursuant to Section 15061(b)(3) General Rule, as it can be seen with certainty that approval of the project will not have a significant effect on the environment, and not subject to CEQA to the extent it implements changes in state law and thus not a discretionary approval, pursuant to Section 15002(i); (2) approve Planning Case PR-2023-001523 Zoning Text Amendment based on the findings summarized in the Planning Commission Staff Report; (3) introduce and subsequently adopt an Ordinance amending Title 19 Zoning of the Riverside Municipal Code; and (4) review the process in one year. The motion carried with Councilmembers Falcone, Cervantes, Perry and Hemenway voting aye and Councilmembers Conder, Robillard, and Mill voting noe.
