

While living overseas, I served on various community boards and community support groups. On two occasions, I served as president of my local homeowners' association. Most recently I served as Chairman of the Mayor's Commission on Aging ((City of Riverside) and the Board of Directors of the Riverside County YMCA. I currently serve as Vice Chairman of the Calif. Republican Assembly- Riverside.

I enjoy public service and feel that I can bring a different perspective to the table.

EXPERIENCE OF SPECIAL KNOWLEDGE PERTAINING TO AREA OF INTEREST:

During my 27 years living and working overseas, great deal of my time and effort was spent working in the public safety arena. As president of my local homeowners' association (Philippines) I was ultimately responsible for the operations and training of a fourteen member police force. Much of my fifteen years in Thailand was spent working in jails, prisons, detention centers. I was involved in a number of covert operations, involving the investigation and recovery of foreign citizens held in "cult" groups. Without going into detail, I will simply make mention of having had a professional relationship with US Intelligence agency.

Aside from involvement in the public safety arena, I have managed up to thirty employees from a variety of cultural and ethnic backgrounds. In any form of negotiations, be they friendly or hostile, I have always managed to approach issues from all perspectives.

In dealing with police and community matters, I believe I would be objective and impartial. I do not believe the police are always right, nor do I believe the public is always right. Justice is not political, nor is it partial.



Successfully established and managed the Concordia Welfare and Education Foundation, Thailand. Interacted with local government officials, United Nations officials, and government officials from foreign governments as a part of the operational process. Planned and carried out numerous public relation projects related to the foundation's programs.

(After five years, I transferred the LIFE Foundation to a larger support organization. Today the program is found in many provinces of Thailand and neighboring countries.)

Conducted all surveys, designed the initial programs, headed all negotiations with the Thai Government and implemented program. Presented over 50 seminars, educational activities and/or public relation functions involving child welfare.
