

**FIRST AMENDMENT  
TO SERVICES AGREEMENT**

**Tree Irrigation Maintenance at RGC**

THIS FIRST AMENDMENT TO SERVICES AGREEMENT (“First Amendment”) is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2024, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation (“City”), and ABILITY COUNTS, INC., California Contractors State License Board No. 698666, a California corporation (“Contractor”), with respect to the following:

**RECITALS**

WHEREAS, on or about June 29, 2023, City and Contractor entered into that certain Services Agreement for Tree Irrigation Maintenance at RGC (“Agreement”); and

WHEREAS, the Agreement is set to expire July 31, 2024; and

WHEREAS, the City and Contractor desire to extend the Term of the Agreement for an additional one (1) year, from August 1, 2024 through July 31, 2025, and to increase compensation in the amount of Twenty-Nine Thousand Four Hundred Dollars (\$29,400.00), for a total compensation amount not to exceed Fifty-Eight Thousand Eight Hundred Dollars (\$58,800.00).

NOW, THEREFORE, in consideration of the foregoing recitals which are incorporated herein by this reference, City and Contractor agree as follows:

1. Section 2, “Term”, is hereby extended for an additional one (1) year period beginning August 1, 2024, through July 31, 2025.

2. Section 3, “Compensation”, is hereby amended to increase the compensation by an additional Twenty-Nine Thousand Four Hundred Dollars (\$29,400.00), for a total compensation amount not to exceed Fifty-Eight Thousand Eight Hundred Dollars (\$58,800.00).

3. All other terms and conditions of the Agreement between the parties, which are not inconsistent with the terms of this First Amendment, shall remain in full force and effect as if fully set forth herein.


