

CITY OF RIVERSIDE NOTICE OF PUBLIC COMMENT PERIOD FOR SUBSTANTIAL AMENDMENT TO THE 2019/2020 HUD ANNUAL ACTION PLAN

NOTICE IS HEREBY GIVEN that the City of Riverside has prepared its draft amendment of the HUD Annual Action Plan for program years 2019/2020. The publication of this notice is the beginning of the public review period required under Federal Regulation 21 CFR 91.105 (b)(2). The Department of Housing and Urban Development (HUD) has granted a waiver to the 30-day minimum public comment period to expedite the use of funds under the Coronavirus Aid, Relief and Economic Security Act (CARES Act). The amendment is scheduled to be presented at the public hearing on October 25th, 2022. The public review and written comment period will begin on October 20, 2022 and run through October 24, 2022.

At this meeting, the City Council will receive public comment on the draft HUD Annual Action Plan 2019/2020 that is to be submitted to the U.S. Department of Housing and Urban Development (HUD).

BACKGROUND

The U.S. Department of Housing and Urban Development (HUD) approved the City of Riverside to adopt the 2019/2020 Annual Action Plan for use of federal entitlement funding from the United States Department of Housing and Urban Development. The Consolidated Plan provides an inventory of existing programs and activities, resources, demographics, unmet needs, and identifies strategies and resources such as the Community Development Block Grant funds (CDBG), HOME, Housing Opportunities for People with AIDS (HOPWA), and Emergency Solutions Grant (ESG) needed to implement programs and activities to address the unmet needs. With the approval of the Consolidated Plan, it is the Annual Action Plan that incrementally addresses and implements identified programs and activities prepared and submitted to HUD for approval. The Annual Action Plan prepared for 2019/2020 implements the strategies and goals identified in the Consolidated Plan. The City is proposing to update this plan to modify the current CDBG CARES Act (CDBG-CV) agreement between the City of Riverside and the United Way of the Inland Valleys (UWIV). The current CDBG-CV Agreement authorized the United Way to administer the Microenterprise Grant Assistance Program on behalf of the City. The program functions to assist local small businesses with five or fewer employees which are owned and operated by lowmoderate income individuals that were impacted by the Coronavirus Pandemic with one-time grants not to exceed \$7,500. The proposed amendment would provide up to \$10,000 for up to 150 businesses. The United Way of the Inland Valleys will re-review all approved applicants for possible "true-up" in an effort to provide an additional \$2,500 if needed. An adjustment of the administration fees not to exceed 20% would be required for continued activity delivery.
