Commissioner Alderette led the Pledge of Allegiance to the Flag.

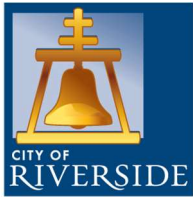
### ELECTION OF OFFICERS

The Planning Commission took a brief recess and reconvened with Chair Wilson presiding and all commissioners present.

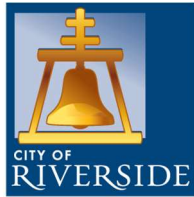

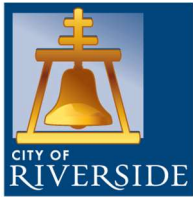
Hearing was called to consider Planning Case PC-2025-00439, a proposal by Matt Reid for TDA Investment Group, to consider a General Plan Amendment, Specific Plan Amendment, and Zoning Code Amendment to consider entitlements to facilitate a land swap of 3.9 acres of land within the Canyon Springs Healthcare Campus Specific Plan (CSHC-SP) with 3.9 acres of land within the Canyon Springs Business Park Specific Plan (CSBP-SP) located on the northwest corner of Canyon Park Drive and Campus Parkway and east side of Canyon Park Drive, south of Campus Parkway. One person spoke on the matter. The public hearing was officially closed.

Following discussion, it was moved by Commissioner Wilder and seconded by Commissioner Singh to recommend that the City Council (1) determine that Planning Case PC-2025-00439 will not result in significant effects on the environment, and therefore the project is consistent with the adopted Mitigation and Monitoring Reporting Program prepared for Planning Case P14-0294 Canyon Springs Healthcare Campus Specific Plan and Amendment to the Canyon Springs Business Park Specific Plan Final Environmental Impact Report ("FEIR" or "Certified FEIR") (State Clearinghouse No. 2016031001); and (2) approve Planning Case PR-2025-00439 General Plan Amendment, Specific Plan Amendment, and Zoning Code Map Amendment based on the findings outlined in the staff report and summarized in the findings and subject to the recommended conditions. The motion carried unanimously.

Following discussion and without formal motion the Planning Commission continued the 2026 Work Plan to the Planning Commission meeting for April 9, 2026.

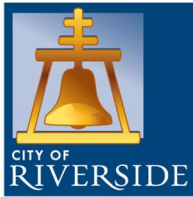
### COMMUNICATIONS
