7. Director's Update regarding the main museum renovation, historic houses, collections, exhibitions and programs, staffing, advisory teams, volunteer and support opportunities, marketing, and communications.

Since the report upload deadline, Director Peterson reported that the Museum has hired an Exhibition Designer who will begin June 9. An event will be held Saturday, July 15, from 1-2:30 p. m. at the Casa Blanca Library for the mini-museum exhibition. An ambitious program calendar for 2024, the Museum's 100th anniversary, will be possible only with the collaboration of our cultural partners as presenters. The Museum has purchased an outdoor inflatable projection cinema and plans to screen films with Riverside connections on the Heritage House garden grounds as part of its 100th anniversary programming. About 75 attended the Open Lobby event on May 18, and the annual Victorian Ice Cream Social at Heritage House saw an estimated 1,750 for the popular event.

Museum staff are providing Harada documents to assist a new program featuring local judges, lawyers, and high school students who will reenact the court case. The event will be held September 21, from 10:00 a.m.- 12:00 p.m. in the Riverside County Courthouse. The Riverside Museum Associates may be requested to sponsor transportation costs for the students to the event.

The Museum website is still in the outline process with City Marketing and will be the last City department website to be updated. New Museum Board member Julie Bjork joined the Museum Design Advisory Team.

Board Chair Zdilor reported that she attended the annual Victorian Ice Cream Social at Heritage House this past Sunday as well as the new Casa Blanca mini-museum at the Salvador Lara Library branch.
