RECITALS

- A. WHEREAS, the City and Consultant entered into that certain Professional Consultant Services Agreement dated November 16, 2023 ("Agreement"), for Economic Development Services Consultant Support, and set to expire on November 1, 2024; and
- B. WHEREAS, the City and Consultant desire to increase compensation in the amount of Sixty-Two Thousand Five Hundred Dollars (\$62,500.00), with a total sum not to exceed Seventy-Five Thousand Dollars (\$75,000.00); and
- C. WHEREAS, the City and Consultant desire to extend the term of the Agreement to November 30, 2024.

NOW, THEREFORE, incorporating the recitals set out above, the parties hereto mutually agree to the following amendment to the Agreement.

- 1. Section 2, Term, is hereby extended to November 30, 2024.
- 2. Section 3, Compensation, is hereby amended to increase compensation by Sixty-Two Thousand Five Hundred Dollars (\$62,500.00), with a total sum not to exceed Seventy-Five Thousand Dollars (\$75,000.00).
- 3. All other terms and conditions of the Agreement between the parties, which are not inconsistent with the terms of this First Amendment, shall remain in full force and effect as if fully set forth herein.
