

RESOLUTION NO.

1 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,  
2 CALIFORNIA, ORDERING, CALLING, PROVIDING FOR AND GIVING  
3 NOTICE OF A GENERAL MUNICIPAL ELECTION TO BE HELD JUNE 4,  
4 2019, TO BE CONDUCTED WHOLLY BY MAIL-IN BALLOT IN THE  
5 CITY OF RIVERSIDE FOR THE PURPOSE OF ELECTING A MEMBER  
6 OF THE CITY COUNCIL FROM THE FIRST, THIRD, FIFTH AND  
7 SEVENTH WARDS OF SAID CITY OF RIVERSIDE FOR FIVE-YEAR  
8 TERMS.

9 The City Council of the City of Riverside does hereby resolve as follows:

10 Section 1: That in accordance with the provisions of the Charter of the City of Riverside  
11 and the Constitution and election laws of the State of California, a General Municipal Election be  
12 held and the same is hereby called and ordered to be held in the City of Riverside on June 4,  
13 2019, for the purpose of electing four members of the City Council of the City of Riverside for  
14 five-year terms. The members of the City Council shall be from the odd-numbered wards of the  
15 City of Riverside as established by the City Council.

16 Section 2: That no polling places will be secured as said election is to be conducted  
17 wholly by mail-in ballot. Official ballots will be mailed together with the sample ballot  
18 pamphlet and a postage prepaid envelope for return of the official ballot. Voted ballots must be  
19 returned to the Registrar of Voters Office or to one of the drop-off locations, at least one of  
20 which shall be located in Ward One, Ward Three, Ward Five and Ward Seven. Voted ballots  
21 must be returned no later than 8:00 p.m. on Tuesday June 4, 2019, or be postmarked on or before  
22 election day and received no later than three (3) days after the election day to be counted.

23 Section 3: That the purpose of holding said General Municipal Election there shall be  
24 and hereby are established consolidated voting precincts consisting of a consolidation of the  
25 regular precincts in the City of Riverside established for the holding of state and county elections  
26 as said regular election precincts exist on the date of this resolution.

27 Section 4: That the form and contents of the ballots to be used at said election shall be as  
28 provided by law.

Section 5: That in accordance with Section 10002 of the Elections Code, the Board of  
Supervisors of Riverside County are hereby requested to consent to the Riverside County

1 Registrar of Voters rendering election services to the City of Riverside as may be requested by  
2 the City Clerk of said City, the County of Riverside to be reimbursed in full for such services as  
3 are performed.

4 Section 6: That the City Clerk shall have charge of all City elections pursuant to  
5 Riverside City Charter section 703(f).

6 Section 7: That the City Clerk is hereby designated the “Elections Official” for the  
7 purposes of this election pursuant to Elections Code section 320(b).

8 Section 8: That based upon the foregoing authority, the City Clerk shall have charge  
9 of this election and shall make all determinations necessary to conducting this election.

10 Section 9: That the City Clerk of said City shall receive the canvass of the General  
11 Municipal Election and shall certify the results to the City Council, as required by law.
