corporation ("Subrecipient"), with respect to the following:

RECITALS

WHEREAS, on or about January 13, 2023, the City and Subrecipient entered into that certain American Rescue Plan Act Subrecipient Agreement ("Agreement") for Social Work Internship Program Called Love Thy Neighbor Collaborative (LYNC); and

WHEREAS, the Agreement is set to expire June 30, 2024; and

WHEREAS, the City and Subrecipient desire to amend the Agreement to extend the Term an additional twenty (20) months, effective July 1, 2024, through February 28, 2026; and

WHEREAS, the City and Subrecipient desire to increase Compensation in the amount of Two Hundred Forty-One Thousand Three Hundred Forty Dollars (\$241,340.00), for total Compensation in the amount of Four Hundred Forty-One Thousand Three Hundred Forty Dollars (\$441,340.00), for the extended Term of the Agreement.

NOW, THEREFORE, in consideration of the foregoing recitals which are incorporated herein by this reference, City and Subrecipient agree as follows:

- 1. Section 2, Term, is hereby amended to extend the Term of the Agreement an additional twenty (20) months, effective July 1, 2024, through February 28, 2026.
- 2. Compensation is hereby increased in the amount of Two Hundred Forty-One Thousand Three Hundred Forty Dollars (\$241,340.00), for total Compensation in the amount of Four Hundred Forty-One Thousand Three Hundred Forty Dollars (\$441,340.00), for the extended Term of the Agreement.
- 3. All other terms and conditions of the Agreement between the parties, which are not inconsistent with the terms of this First Amendment, shall remain in full force and effect as if fully set forth herein.
