

**FOURTH AMENDMENT TO MASTER AGREEMENT

FOR VARIOUS CITY LOCATIONS ON AN AS-NEEDED BASIS**

THIS FOURTH AMENDMENT TO MASTER AGREEMENT FOR WATER UTILITY TRENCH RESURFACING/ASPHALT PAVING WORK FOR VARIOUS CITY LOCATIONS ON AN AS-NEEDED BASIS (“Fourth Amendment”) is made and entered into this _____ day of _____, 2022, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation (“City”), and R.J. NOBLE COMPANY, a California corporation (“Contractor”), with respect to the following facts:

RECITALS

WHEREAS, on or about April 25, 2011, City and Contractor entered into a Master Agreement for Water Utility Trench Resurfacing/Asphalt Paving Work for Various City Locations on an As-Needed Basis (“Agreement”); and

WHEREAS, on or about December 4, 2013, City and Contractor entered into a First Amendment to Master Agreement for Water Utility Trench Resurfacing/Asphalt Paving Work for Various City Locations on an As-Needed Basis (“First Amendment”), extending the term to October 23, 2016; and

WHEREAS, on or about October 21, 2016, City and Contractor entered into a Second Amendment to Master Agreement for Water Utility Trench Resurfacing/Asphalt Paving Work for Various City Locations on an As-Needed Basis (“Second Amendment”), extending the term to October 23, 2019; and

WHEREAS, on or about September 27, 2019, City and Contractor entered into a Third Amendment to Master Agreement for Water Utility Trench Resurfacing/Asphalt Paving Work for Various City Locations on an As-Needed Basis (“Third Amendment”), extending the term to October 23, 2022; and

WHEREAS, the Agreement will expire on October 23, 2022, but may, subject to mutual consent, be extended for successive three-year terms; and

WHEREAS, City and Contractor desire to extend the term of the Agreement by three years, to October 23, 2025.

NOW, THEREFORE, in consideration of the foregoing recitals which are incorporated herein by this reference, City and Contractor agree as follows:

1. The term of the Agreement is hereby extended by three years, or until October 23, 2025.

2. All terms and conditions of the Agreement not inconsistent with this Fourth Amendment, shall remain in full force and effect and are incorporated herein by this reference as if set forth in full.

IN WITNESS WHEREOF, City and Contractor have caused this Fourth Amendment to Master Agreement for Water Utility Trench Resurfacing/Asphalt Paving Work for Various City Locations on an As-Needed Basis to be duly executed on the day and year first above written.
